May 29:

Calls of Note

A woman contacted the Police Department that her 20 year old son, who is on the spectrum, was acting out. PO's Leone, Charles and Holly, (who has established a relationship with this young man), responded and spent 25 minutes with him until he was able to regulate his behavior.

- He did not require hospitalization.

June 8:

Calls of Note

A young woman suffered a severe laceration to her arm, to the point where she was losing consciousness from blood loss. PO's Burns and Casale responded and applied a tourniquet to staunch the bleeding.

Multiple medical professionals have noted
that their response and treatment saved her
life.


 The Field Training of Officers Charles and Paredes was completed in early May.




