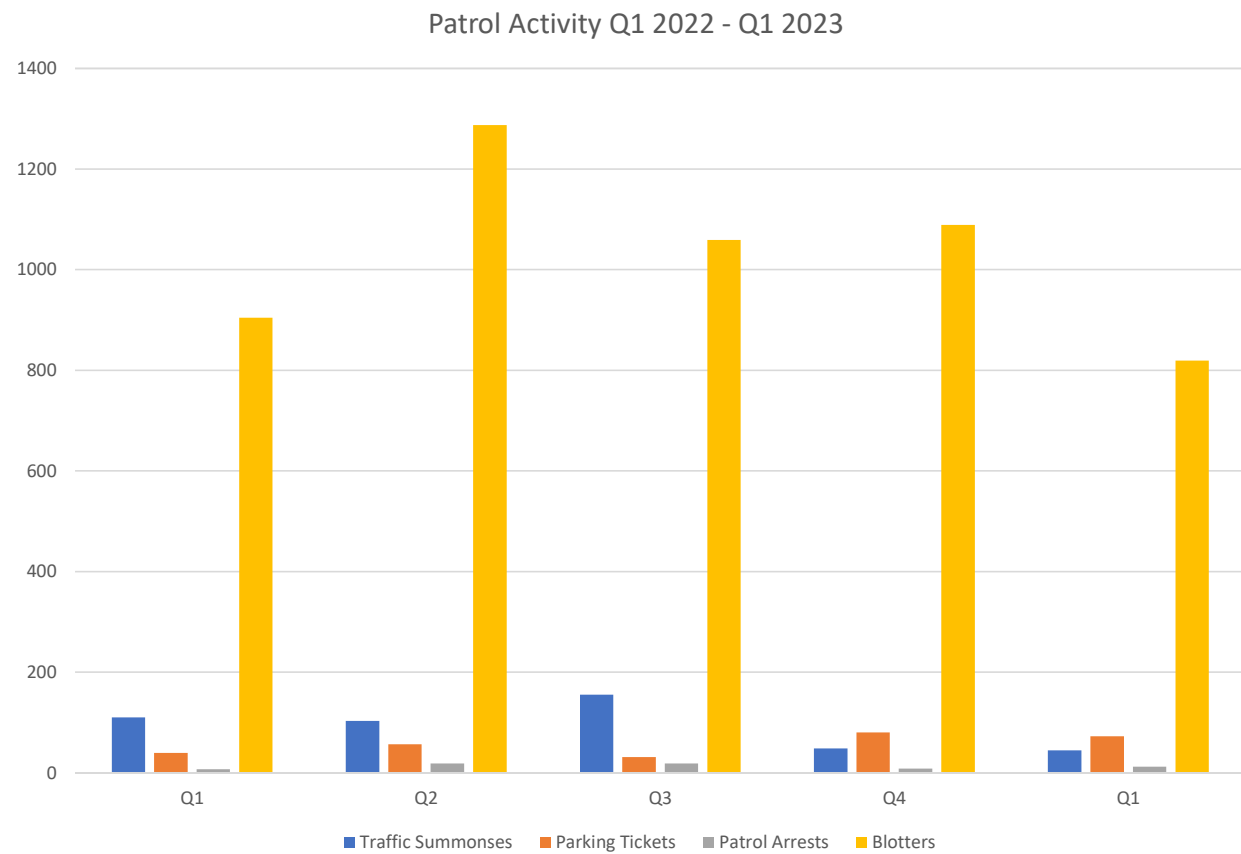

## Calls of Note

### March 25:

- A 32 year-old Thornwood resident was arrested after it was determined that he had been stealing numerous scratch-off lottery tickets from a local convenience store in the Village over the time span of one month. The defendant was arraigned in the Village of Pleasantville Justice Court on the charge of Grand Larceny in the 4<sup>th</sup> degree (E-Felony) and was released without bail pending a future court appearance, and a temporary order of protection barring him from the store was issued.

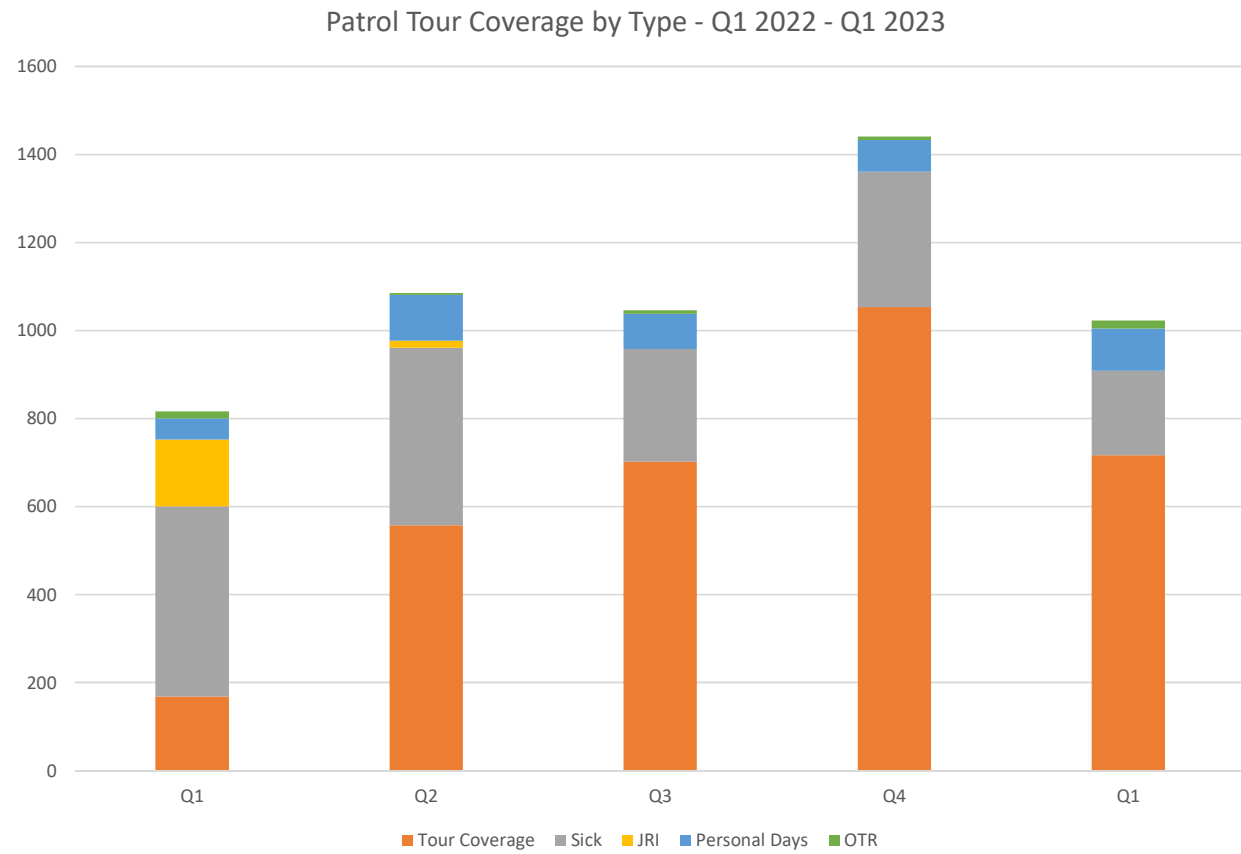

**We expect our Officer's interactions with juveniles and their families will increase as we enter into the Spring and Summer.**

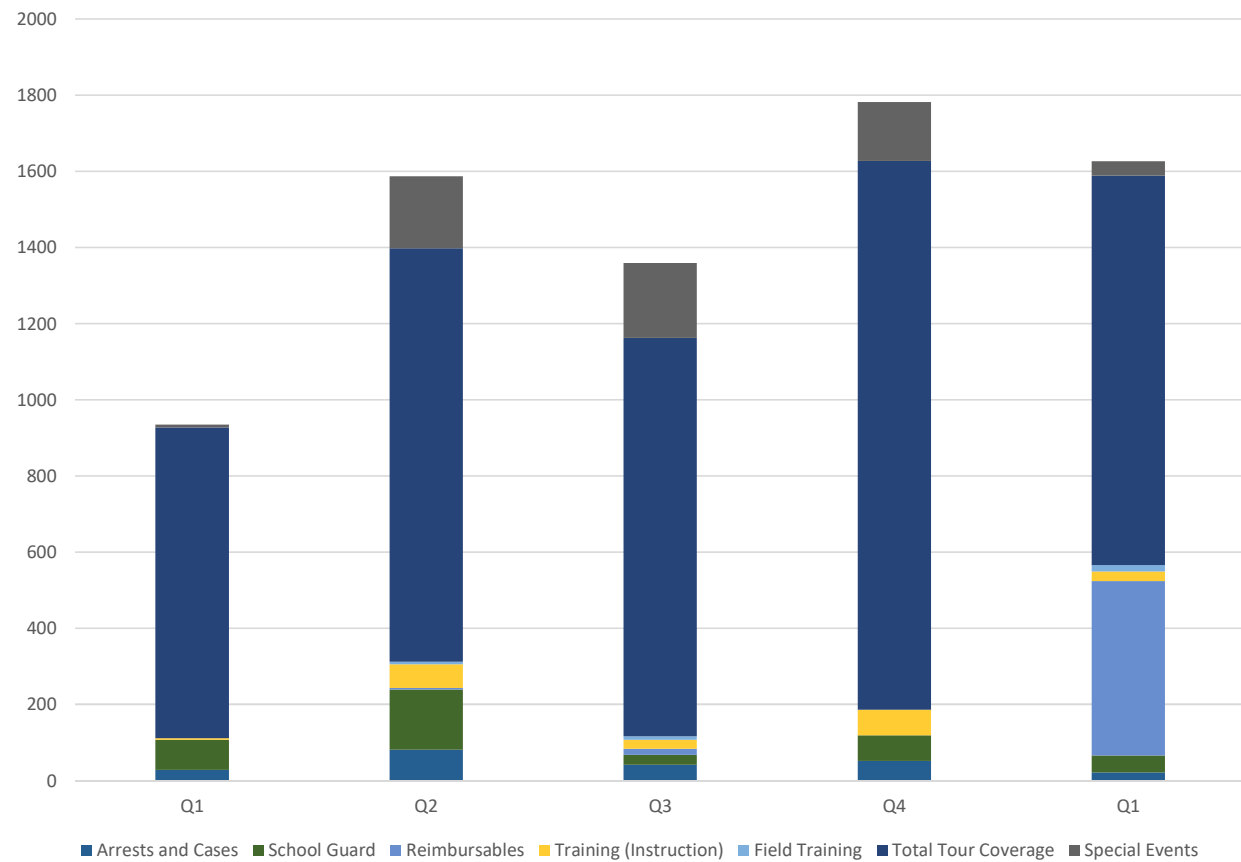
