## 6/07/2022 through 6/12/2022

The Blotter reports below represent a selection of reports made between the dates above.

06/07/2022 8:50am A female resident of Foxwood Drive reported a possible violation of a Family Court Order of Protection which protects her from the father of her child. The woman claimed he was using a court-authorized messaging app to harass her. After interviewing the man the next day, it was determined that he had committed a violation of the order. The man was placed under arrest and arraigned before the Village Justice.

06/07/2022 11:57am Det. Sergeant Garcia reported he transported the contents of the DEA Drop Box, located in the Police Lobby, for destruction.
