BLOTTER SUMMARY

1/17/2022 through 1/23/2022

The blotter reports listed below represent a selection of reports made between the dates listed above.

CORRECTION: On the Blotter Report issued for January 5, details of a call for service were incorrectly reported. The original report to the police department was not made by the driver of the vehicle, but by a neighbor. Additionally, the Blotter Summary was not clear that the driver of the vehicle involved in the second accident was unaware of the icy road conditions that contributed to the first accident prior to leaving his house. The Police Department apologizes for the error and any confusion it may have caused.
