

BLOTTER SUMMARY

October 2 through October 8, 2023

The Blotter reports below represent a selection of reports made between the dates above.

10/02/2023 9:14am A resident on Bedford Road requested medical assistance for severe abdominal pains. The ambulance and paramedics were dispatched, and responding officers provided assistance until they arrived. The patient was transported to the hospital by Pleasantville VAC.

10/02/2023 9:50 am The central monitoring station for an alarm company reported a commercial burglary alarm at a business on Clinton Street. The responding officers determined that the alarm was caused by workers performing maintenance on the security system.

10/02/2023 12:54 pm The owner of a restaurant on Bedford Road reported an unconscious party who may have suffered a fall on the floor in their establishment. The paramedic and ambulance were dispatched, and responding officers were able to wake the man, who stated the he was just sleeping. Following an evaluation, the man refused medical attention.

10/02/2023 5:49pm An anonymous party called to report several vehicles parked in the no parking zone on Lincoln Avenue and Elm Street. The responding officer observed the vehicles parked in violation, and issued summonses to both.

10/02/2023 6:32pm A resident of Eastview Avenue reported two youths "play fighting" in the roadway of Washington Avenue near Manville Road. The responding officers located the two youths involved and advised them to stay out of roadway for their safety.

Further investigation revealed that the resident was currently away, and a follow up call assured officers that the resident was accounted for and at a safe location.

10/03/2023 1:32am The central monitoring station for an alarm company reported an activated burglar alarm at a restaurant on Marble Avenue. The responding officers checked the premise, and it appeared secure.

The caller was transferred to County Fire Control, and responding officers determined that the alarm was due to a dead battery in the CO detector. The scene was cleared by the Pleasantville FD.

EMS was dispatched, and the responding officers provided medical assistance until they arrived. After a preliminary evaluation by the paramedic and the ambulance crew, the patient refused any further medical attention.

The officers were able to deescalate the situation, and facilitate the end of the transaction.

The responding officers located two local youths, who stated they had permission to ride their dirt bikes on private property. The officers did not observe the youths riding on public roads, and the youths pushed their bikes home.

10/08/2023 6:42pm A resident of the Village reported a vehicle on fire on the southbound lane of the Saw Mill River Parkway underneath the Pleasantville Road bridge. Pleasantville FD and Westchester County Police were requested to respond. The responding officers reported a flatbed truck carrying a float ornament was stopped under the bridge with its front passenger tire on fire. The officers attempted to put out the flames, and the fire was extinguished by Pleasantville FD personnel.

10/08/2023 10:22pm A juvenile attending a party at a local establishment reported his 14-year-old friend had been struck in the face by an intoxicated adult. The responding officers conducted a preliminary investigation and identified both the perpetrator and the victim. The incident is currently under investigation.
