## **BLOTTER SUMMARY**

## November 13<sup>th</sup> through November 19<sup>th</sup>, 2023

The Blotter reports below represent a selection of reports made between the dates above.

11/13/2023 7:58am County Fire Control reported they were dispatching EMS to a residence on Mountain Road for a person who suffered injuries from a fall. Officers attempted to keep the woman comfortable pending the arrival of the ambulance and the paramedic. The patient was transported to the hospital via Pleasantville VAC.

11/13/2023 10:45am While on patrol, an officer was flagged down by one of the persons involved for a motor vehicle accident where a tractor trailer struck a parked vehicle on Castleton Street. No injuries were reported, and a NY State Accident Report was filed.
