

BLOTTER SUMMARY

November 27rd through December 3rd, 2023

The Blotter reports below represent a selection of reports made between the dates above.

11/27/2023 5:43 am An uninvolved driver reported a pedestrian struck by a car at the intersection of Manville Road and Vanderbilt Avenue. Responding officers found the pedestrian seated in the roadway suffering from injuries to his leg and bleeding from the back of his head. The ambulance and paramedic were dispatched. The investigation determined the pedestrian had crossed the street and was struck by a vehicle travelling westbound on Manville Road, whose driver remained at the scene. Upon the arrival of the ambulance and the paramedic, the patient was transported to the hospital by Pleasantville VAC and a NY State Accident Report was filed.

11/27/2023 8:57am County Fire Control dispatched EMS to a home on Meadow Lane for a woman with difficulty breathing. Responding officers administered oxygen awaiting the arrival of the ambulance and the paramedic. The patient was transported to the hospital via Pleasantville VAC.

11/27/2023 9:55am Mount Pleasant PD requested mutual aid for a young person who is experiencing emotional disturbance at a residence just outside the Pleasantville jurisdiction. Responding officers remained on scene and assisted the person in distress until Mount Pleasant officers arrived.

11/27/2023 8:52pm Officers responded to a residence on Washington Avenue for a reported domestic dispute in progress between a mother and son. Responding officers were able to deescalate the situation. A NY State Domestic Incident Report was filed.

11/28/2023 3:46 am A resident of Otsego County, NY requested assistance for his mother, who lives on Hobby Street, as she was not feeling well. The ambulance and paramedic were dispatched, and responding officers prepared the woman for transport upon their arrival. She was taken to the hospital via Pleasantville VAC.

11/28/2023 8:39am Westchester County PD requested assistance locating a vehicle wanted by their agency for fleeing a vehicle stop in the recent past. Responding officers canvassed the area and located the car, unoccupied, on Manville Road. County PD was notified of the location and responded.

11/28/2023 12:16pm A resident of Manville Road reported a vehicle blocking a fire hydrant near his home. The responding officer discovered that the vehicle had left prior to his arrival.

11/28/2023 12:52pm Staff of the Senior Center reported that a resident had fallen outside the building, and requested assistance getting the woman back to her feet. Upon arrival, officers helped her up and determined that she would benefit from a medical evaluation, so EMS was dispatched. Following the evaluation, the patient refused further medical treatment and was escorted safely home.

11/28/2023 6:02pm A resident of Brewster requested assistance locating his step-daughter, who lives in the Village, as she had not been answering her phone for the previous 24 hours. The caller did not believe she was missing, only out of communication. After a brief investigation, the responding officers were able to determine that she was safe.

11/29/2023 11:29am A resident on Orchard Street reported low hanging wires in front of his home. The responding officer confirmed that cable service wires were approximately 10 feet above the sidewalk, and Verizon was notified.

11/30/2023 12:29pm A resident of Vanderbilt Avenue reported a garbage truck had pulled down service wires near the intersection of Depew Street. The responding officers located the truck and the driver and secured the wires. Verizon was contacted to respond for repair, and a report was filed.

11/30/23 1:50pm A business owner on Cooley Street reported an unknown vehicle parked for several days in the business's private lot. The responding officer contacted the owner, who reported she had permission from the owner to park there, which was confirmed.

11/30/2023 2:50pm A resident of Meadow Lane reported a three car accident, in which one vehicle had left the scene. EMS was dispatched via County Fire Control, and responding officers determined through investigation that the accident only involved two cars, not three. Following a medical evaluation, the driver refused medical attention. A New York State Accident Report was filed.

11/30/2023 3:51pm A resident of Roselle Avenue reported signage on Manville Road warning trucks not to enter the Saw Mill Parkway had been knocked down. After confirming the damage, the responding officer notified the NY State Traffic Management Center to restore the sign.

11/30/2023 4:43pm A local resident requested medical attention for his mother-in-law, who lives on Saratoga Avenue, after he came to her home and found her on the floor. The ambulance and the paramedic were dispatched, and the responding officers found the woman conscious and responsive but suffering from injuries from her fall. She was transported via Pleasantville VAC to the hospital.

12/01/2023 5:43am A resident of Mountain Road reported a suspicious vehicle, parked with its parking lights on, for the past twenty minutes at intersection with Crawford Street. As the officers responded, the caller called back and advised the vehicle had left the area. Patrol units canvassed the area with negative results.

12/01/2023 10:08am A resident of Bedford Road reported a hit and run accident in which a truck damaged several mailboxes near her home and fled the scene. A vehicle description was provided, and following an investigation, responding officers were able to determine the vehicle's owner. A NY State Accident Report was filed, and the driver was issued a summons for Leaving the Scene of a Property Damage Auto Accident.

12/01/2023 11:12am The central monitoring station for a personal health monitoring company reported that the medical alert pendant of a resident of the Clinton Street Center had been activated, and they received no response when they tried to contact her. Upon arrival, the responding officer found the resident in good health and that the activation was accidental. He assisted her to reset the medical alert machine.

12/01/2023 5:12 pm One of the drivers involved reported a property damage auto accident at the intersection of Broadway and Lake Street. Once on scene, responding officers determined that a passenger in one of the vehicles had suffered a minor head injury. EMS was dispatched, and officers assisted in the evaluation and preparation for transport. A NY State Accident Report was filed, and the patient was transported to the hospital via Pleasantville VAC.

12/01/2023 10:47pm County Fire reported they were dispatching EMS to a business on Irvington Street for an intoxicated party. Responding officers assisted the ambulance and paramedic as the patient, a 42-year-old man from Briarcliff, was taken to the hospital via Pleasantville VAC.

12/02/2023 5:00am Despite posted signage, two vehicles were impounded from the Memorial Plaza Lot for violation of the parking rules for the Pleasantville Farmer's Market.

12/02/2023 1:41pm The Desk Officer observed a disabled vehicle stopped blocking traffic on Bedford Road. Responding officers requested a tow truck, and the vehicle was removed for repairs.

12/02/2023 2:53pm An Amazon delivery driver reported being bitten by a dog while delivering to a home in the Village. EMS was requested to respond, and responding officers determined the bite had broken the skin. The animal's vaccination status was confirmed, and a report was filed with the Westchester County Department of Health. The patient was transported to the hospital via Pleasantville VAC.

12/02/2023 6:09pm The central monitoring station for an alarm company reported a commercial alarm at a business on Washington Avenue. Responding officers checked the exterior of the building and found it to be secure on the ground level.

12/03/2023 7:47am While on patrol, an officer observed the front door of a business on Bedford Road had been smashed and that the store had been burglarized. After determining that no one was still inside, the crime scene was secured and detectives were called to respond. The investigation is ongoing.

12/03/2023 1:09pm A local resident came to Police HQ to report fraud on his credit card. The matter is under investigation.
