BLOTTER SUMMARY

The Blotter reports below represent a selection of reports made between the dates above.

11/06/2023 11:24am An acquaintance of a woman who works at a business on Tompkins Avenue reported an unknown Lyft driver had been taking photos of two women as they walked down the street. Responding officers gathered a physical description of the man and of his car, and the investigation led to him being identified. Upon being contacted, he reported he had been in the area but was not taking pictures of the women, merely securing his next rideshare customer.
