

BLOTTER SUMMARY

December 11th through December 17th, 2023

The Blotter reports below represent a selection of reports made between the dates above.

12/11/2023 12:45 pm A resident of Bedford Road came to Police HQ to report that it appeared someone had attempted to gain entry to her vehicle while it was parked outside her home. The reporting officer noted there were scuff or gouge marks on the driver side door. The caller wished to document the incident only at this time.

12/11/2023 2:03 pm A business owner on Manville Road reported a vehicle revving its engine in front of his store. The responding officer canvassed the area, but the vehicle was gone on arrival.

12/11/2023 7:23pm While on routine patrol, PO Charles reported a truck towing a camper on the Saw Mill Parkway just south of Grant Street, but north of the underpass. County PD was notified, and the reporting officer assisted to remove the prohibited vehicle from the Parkway.

12/12/2023 10:59 am A business owner on Manville Road reported that a person on the phone had made multiple attempts to use an unauthorized credit card to make a purchase over the phone. The responding officer took a report, and an investigation is being conducted.

12/12/2023 2:27 pm County Fire reported they were dispatching Pleasantville FD to a residential fire alarm on Court Street. Responding officers determined the alarm was accidentally activated by the homeowner, and Pleasantville FD cleared the scene.

12/12/2023 8:46pm A local resident reported a slow-moving van, westbound on Bedford Road. The responding officer located the van and determined it was staff from a local residential treatment facility following an AWOL student.

12/13/2023 1:14 am County Fire Control reported they were dispatching EMS to a residence on Grant Street for a man suffering from chest pain. Responding officers

administered oxygen pending the arrival of the ambulance and the paramedic. The patient was transported to the hospital by Pleasantville Ambulance.

12/13/2023 4:35pm A local couple out for a walk reported a gray pickup truck with a megaphone on the roof, blaring an unknown message as it traveled westbound on Bedford Road near the old Village. Responding officers canvassed the area with negative results.

12/13/2023 5:35pm A resident of Edgewood Avenue called to report a vehicle in violation of the parking restrictions for several days on Grove Street. The responding officer determined the car was currently parked legally, but the midnight shift was advised to check for overnight violations.

12/13/2023 8:02pm A resident of Hastings requested medical assistance for her spouse, who suffered a dislocated hip while patronizing a business on Tompkins Avenue. EMS was dispatched, and responding officers attempted to keep the man comfortable pending their arrival. The patient was transported to the hospital via Pleasantville VAC.

12/13/2023 8:33pm A person walking on Wheeler Avenue called 911 to report she was experiencing chest pains. The woman eventually walked into Police HQ, and EMS was requested to respond. Responding officers provided first aid while awaiting their arrival. The patient was transported to the hospital via a mutual aid ambulance.

12/14/2023 10:15am While on patrol, PO Salameh reported a disabled vehicle in the roadway on Marble Avenue at the intersection of Bedford Road. A local tow company was dispatched, and the vehicle was safely moved out of the roadway.

12/14/2023 2:35pm A resident of Weskora Avenue reported a man at her door, who she believed was looking to steal packages. When the woman addressed him via her Ring camera, he stated he was a contractor soliciting work. Responding officers located the man and confirmed he was a contractor, but since he did not have a permit, he was told to stop soliciting.

12/14/2023 5:57pm County Fire Control reported they were dispatching EMS to a residence on Clinton Avenue for an unresponsive party. Responding officers found the man had

regained consciousness. Upon arrival of the ambulance and the paramedic, he was transported to the hospital via Pleasantville VAC.

12/15/2023 8:51am The central monitoring station for an alarm company reported a general alarm at a business on Manville Road. Responding officers determined that the alarm was set off in error by an employee.

12/15/2023 11:26 am A resident of Washington Avenue requested an ambulance for her boyfriend, who was unable to ambulate. EMS was dispatched, and responding officers attempted to keep the man comfortable pending their arrival. The patient was transported to the hospital via Pleasantville VAC.

12/15/2023 4:15pm A local resident came into Police HQ to turn in a wallet he had found on Wheeler Avenue. An officer was able to contact the owner, who came to HQ to retrieve it.

12/15/2023 5:48pm An appliance repairman doing work for a client in the Village reported a verbal dispute with the homeowner. Responding officers deescalated the situation to the point that the caller was able to gather his tools and leave without further issue.

12/16/2023 5:00am Despite posted signs, one vehicle was impounded from the Memorial Plaza lot for violation of the parking ordinances for the Farmer's Market.

12/16/2023 7:05am An unknown person reported a dispute with the clerk at a convenience store on Pleasantville Road. Officers checked the area, but determined the caller was mistaken about the location, so Mount Pleasant PD was notified and checked their convenience stores. When the caller subsequently called back, the call was forwarded to Mount Pleasant and handled there.

Responding officers separated the parties and interviewed them, and determined that the argument was verbal only over driving lessons. A report was taken to document the incident, and a NY State Domestic Incident Report was filed.

12/16/2023 12:53pm A resident of Thornwood reported that his vehicle had been struck by another vehicle while they had left it parked in Memorial Plaza. The suspect vehicle was still there, but the driver had left the scene. After a short investigation, the suspect driver was identified and asked to respond to Police HQ for follow up. A NY State Accident Report was filed, and a summons was issued to the driver for Leaving the Scene of a Property Damage Auto Accident.

12/16/2023 3:00pm A local resident reported that her their son, who is a new driver, had just come home and believed he had struck another car on Bedford Road with his passenger mirror, but was unsure where. The responding officer canvassed the area, but did not locate a vehicle with damage consistent with an accident as it was reported. A report was made to document the incident.

12/16/2023 8:19pm A local resident reported that she and her husband had just been in a domestic dispute, and that he left the home after ingesting a large number of pills. Responding officers began an investigation, and a vehicle and personal description were broadcast to surrounding police agencies. The man's vehicle was located and stopped a short time later by officers from the Mount Pleasant Police Department, and he was taken into custody and transported to the hospital without incident.

12/16/2023 11:38pm A neighbor reported a loud house party on Douglas Drive. The responding officers located the source of the noise and advised the homeowner to turn off the music and move the festivities inside.

12/17/2023 10:31am A resident of Washington Avenue called to request medical assistance for a family member who was suffering from chest pains and having difficulty breathing. EMS was dispatched, and responding officers assisted the woman pending their arrival. The patient was transported to the hospital for further medical treatment via Pleasantville VAC.

The dogs were described as a Husky and a Golden Retriever, and were last seen running towards the village border near Choate Lane. Officers from both Pleasantville and Mount Pleasant were dispatched but the search was negative.
