December 4th through December 10th, 2023

The Blotter reports below represent a selection of reports made between the dates above.

12/04/2023 12:13am A resident on Bedford Road reported a dog barking for an extended period of time. Responding officers located the dog, who was alone inside a residence on Summit Place.

12/04/2023 9:01am An officer on patrol was flagged down by a resident who had found items on his property that did not belong to him. The resident asked the officer to assist in removing the items, and the officer helped to clear away the debris.

12/04/2023 09:53am Village parking enforcement reported a driver in a vehicle on Wheeler Avenue that was having difficulty operating the vehicle. Responding officers located the vehicle and determined the driver had gotten the gas pedal stuck to the floor by accident while the vehicle was in park. The situation was corrected.

They provided basic medical assistance until the paramedic and ambulance arrived, and the woman eventually refused further medical treatment.

Medical assistance was dispatched, and responding officers provided medical aid pending their arrival. The woman eventually refused further medical interventions, and decided to find her own way to the hospital.

Responding officers located the man as he was leaving the store. The man was highly agitated, cursing at the officers, and refused to provide any pedigree information, but eventually agreed to leave.
