The blotter reports listed below represent a selection of reports made between the dates listed above.

12/13/2021 9:52am A resident of Pleasantville walked into Pleasantville Police HQ and turned in an envelope which he had found on the street containing a large sum of cash. A property receipt was issued to the party who turned it in, and officers have attempted to contact the rightful owner.
