

## **BLOTTER SUMMARY**

**1/31/2022 through 2/6/2022**

The Blotter Reports listed below represent a selection of reports made between the dates listed above.

01/31/2022 3:35am A resident of Bedford Road called to report she smells something burning outside of her residence. Responding officers traced the smell back to the chimney of one of the buildings at Foxwood Condominiums, which was exuding a heavy, oily smoke. Pleasantville FD was dispatched. Police and Fire cooperated with the property manager to get into the boiler room and address the situation.

01/31/2022 12:51pm A woman who lives in Foxwood Condominiums came to Police Headquarters to report she has experienced multiple instances where people pound on her door and when she answers, no one is there. The most recent occurrence happened at 4:00 am. A report was filed, and the officer advised her on measures she could take to address the situation.

01/31/2022 8:12pm A resident of Valhalla reports he was doing a welfare check on his brother-in-law, who lives on Bedford Road, and found him at his residence in medical distress. Responding officers administered oxygen and provided basic life saving measures while awaiting the ambulance. The patient was transported via Pleasantville VAC to the hospital.

02/01/2022 8:19am A resident of Pleasantville came to Police HQ to report that ten minutes in the past, she had left her car unlocked as she entered a coffee shop on Wheeler Avenue. When she returned to her vehicle, she noticed her purse was missing from the front passenger seat. She provided a description of a man who she had seen in the area of her car as she went inside the store. A man matching the description she provided was located on the platform of the Pleasantville train station, holding the victim's purse. He was arrested and brought before the Village Court for arraignment.

02/01/2022 9:56am A resident of Pleasantville called 911 to report that her son is acting out violently due to a family dispute. Multiple officers responded to assist with calming the situation, and the young man was able to regain control of his emotions. His mental health service provider was advised, and the Westchester County Department of Mental Health was contacted for a crisis team response.

02/01/2022 10:18am Lt. Wollman and Chief Grutzner report they are at Pleasantville High School to assist and participate in the lockdown drill being conducted.

02/02/2022 2:09pm A resident of Pleasantville reports his vehicle is dying on Manville Road. Responding officers assisted in moving the vehicle from the roadway, and they provided the vehicle owner information for a tow company.

02/02/2022 5:42pm Officers were dispatched to a residence near the Village boundary to assist Mount Pleasant PD with a young woman who may be having suicidal ideation. Officers were able to assist MPPD in keeping her safe and making sure the young woman's family was apprised of the situation and discussing care options.

02/02/2022 9:42pm A resident of Bedford Road called 911 to report that within the last 30 minutes, his car was struck while parked on the street in front of his residence. Officers conducted a canvass of the area for witnesses or cameras that may have recorded the incident, and a report was filed.

02/03/2022 1:59pm A woman who lives in the Sherman Park area of Pleasantville reported that her identity may have been compromised. She reported that she had been contacted by a credit monitoring service of new lines of credit that had been opened in her name. In addition, her employer had informed her that a new unemployment claim had been filed. A report was made, and the officer advised her of steps to take to protect her identity.

02/03/2022 8:18pm Following a domestic dispute on Wheler Avenue, the father of a young child took his son from the mother and left to an unknown location. Responding officers had to negotiate a language barrier, but ascertained enough information from the complainant to determine the address where the father lived. With the assistance of the Westchester County Department of Public Safety and the Ossining PD, the young boy was located and returned to his mother. The investigation is continuing.

02/03/2021 11:21pm The boyfriend of a woman who lives on Bedford Road reports his girlfriend is passed out in her residence. Suspecting an opioid overdose, responding officers administered two doses of Naloxone, which revived her. The ambulance and the paramedic were dispatched, and the patient was transported to the hospital by Pleasantville VAC.

02/04/2022 6:38am A resident of the Bronx contacted this department requesting a welfare check on her ex-boyfriend, who she reports had sounded despondent and she feared would hurt himself in an unsolicited phone call. The caller only knew her ex-boyfriend's address from the time they were together, but upon their arrival, responding officers discovered he no longer lived there. After multiple phone calls to both his parents, the officers were able to determine he had moved next door to his old address. The man was located there, and it was determined he was not a threat to harm himself.

02/04/2022 08:01am A caller reports a vehicle parked in the roadway unoccupied, unlocked, and with personal property inside, on Bedford Road. The Desk officer contacted the registered owner and informed him that the vehicle was blocking traffic and would need to be towed. The registered owner stated his daughter had left the car after it ran out of gas, and he would be responding to the tow yard to retrieve it.

02/04/2022 3:18pm A woman called the Police Desk to report that her ex-husband was not at his residence to participate in the exchange of custody of their children as per a Family Court order. When reached by phone, the father reported he had taken his children to his mother's house outside the jurisdiction when school had been closed for the day, but he did not feel safe driving back to Pleasantville on icy roads. The man agreed to participate in the exchange if his ex-wife would respond to the grandmother's home to retrieve the children, which she did. A report of the incident was made.

02/04/2022 4:52pm A resident of Foxwood Condominiums requested a welfare check on her elderly neighbor. The caller had seen her neighbor fall earlier in the day and was concerned for his well-being. The responding officer found the man to be in good health and good spirits.

02/05/2022 2:32am A woman who lives in the Sherman Park area of Pleasantville called to report that her husband was experiencing chest pain. Responding officers administered oxygen while awaiting the arrival of the paramedic and the ambulance. The man was transported to the hospital by Pleasantville VAC.

02/05/2022 11:00am A resident of Hopper Street reported that a loose Husky was on her front steps, barking at her dog inside her home. The caller believed the dog belongs to her neighbor. The owner was contacted, and he responded to the location to retrieve his loose dog.

02/05/2022 8:49pm A resident of Armonk called to report that she has struck a parked car on Maple Hill Road, but she cannot locate the owner. Officers were able to contact the owner through the vehicle's registration information, and a New York State Accident report was filed.

02/05/2022 9:02pm A resident of Marble Avenue reports a car is blocking the driveway to his residence. The responding officer issued a parking summons to the vehicle.

02/06/2022 12:52am A resident of Pleasant Avenue reports hearing construction noise from what he believes to be the new building on Depew Street, in violation of the noise ordinance. Responding officers located the source of the noise as work being done on the Metro North rail line.

02/06/2022 3:59pm A resident of Pleasantville called to report that unknown person(s) had thrown eggs at her house and her car in the overnight hours. A canvass of the area was conducted and video footage was secured. The investigation is continuing.
