## **BLOTTER SUMMARY**

## 2/21/2022 through 2/27/2022

The blotter reports listed below represent a selection of reports made between the dates listed above.

02/21/2022 1:00pm A caller from Bedford Road reported and man aggressively panhandling in the downtown area. Responding officers located the party and interviewed him about his actions and assessed his mental state. The man, who is homeless, was eventually convinced to be transported for a psychiatric evaluation.

02/21/2022 3:23pm The police desk received an anonymous call complaining of loud outdoor music being played on Marble Avenue. Officers located the source of the music but determined it was not unreasonably loud.

02/21/2022 5:27pm A resident of Broadway came to Police HQ to report she has been receiving unwanted communication from her ex-boyfriend. Although she did not want to file criminal charges or seek an order of protection, she wanted the issues documented. A report was filed and officers will remain in touch with her to continue to assess the ongoing situation.

02/21/2022 6:29pm A resident of Pleasantville called to report that he had been receiving threatening phone calls from an unknown party. The reporting person had no idea who had made the calls, and was not aware of anyone who would want to do him harm. Although the caller to the man did not give any information that would indicate this was anything beyond a prank, the reporting person was advised to contact the Police Department if he saw anything that might represent a threat, and a report was filed.

02/21/2022 7:18pm A local resident reported that she had received notifications that two (2) Amazon packages had been delivered to her home, but she could not locate them. After checking out the picture of the packages that was sent by the delivery driver, the Officer observed that the photo was not of the caller's front porch. The packages were found on her next-door neighbor's patio.

02/22/2022 4:00am Police received a 911 hang-up from the Con Edison substation on Manville Road. Police investigated and found the entrance to the facility locked and no vehicles parked inside the station: all appeared secure.

02/22/2022 10:28am This Department was notified by Ring Security of an alarm activation at a residence, after which they had been notified by a member of the household that no one should be at the residence. Responding officers located a party in the basement who was making sausage in the basement with the knowledge of another household member.

02/22/2022 6:46pm An employee of a restaurant called to report that an ex-employee was at the restaurant and was refusing to leave. Responding officers escorted the party from the location without further incident.

2/22/2022 9:14pm This Department was contacted by Westchester County Fire Control reporting a 91-year-old female with a shoulder injury from a fall. Officers were dispatched to the woman's location along with Pleasantville VAC and a paramedic. The patient was transported to the hospital.

02/23/2022 7:46am An off-duty Emergency Medical Technician called from a coffee shop on Washington Avenue and reported that while he had not been threatened directly, there was a man inside the store talking loudly about killing police officers. The EMT was unsure if the man thought he was a police officer because of his uniform. The EMT further reported the man had left the shop and is on foot in the area. Responding officers located the party and interviewed him. While the man was making outrageous claims, officers did not assess him to be a threat to himself or others, and was directed to the appropriate bus stop to return home.

2/23/2022 12:02pm Police received call reporting a domestic dispute between a father and his adult son. Upon interviewing the father, he stated his son had intentionally damaged the father's cell phone. The son was placed under arrest for criminal mischief and was transported to police HQ for processing. Following his arraignment, the defendant was released, and an Order of Protection was issued by the Village Court. In addition, a New York State Domestic Incident Report was filed.

2/23/2022 9:30pm The Security Coordinator for Pace University reported that a bus stop sign/kiosk from the Pace U. stop at Memorial Plaza and Bedford Road is missing. Further investigation revealed that the sign had been knocked down by a private garbage truck, and then picked up later by a Pleasantville DPW garbage truck. DPW Foreman was contacted and will replace it shortly.

2/24/22 9:57am The manager of a laundromat on Wheeler Avenue reported an unwanted party, again, loitering in her place of business. The man had left the scene, but was located a short time later by responding officers and advised to no longer enter the establishment. The officers also worked with the business manager to document the notification and violation procedures.

02/24/2022 2:58pm A caller from Romer Avenue reports an elderly party has fallen and needs medical assistance. Upon arrival, responding officers discovered the man had lacerations to his face. The man was treated while awaiting the arrival of Pleasantville VAC and the paramedic. He was transported to the hospital for treatment.

2/24/2022 6:18pm An employee of a restaurant on Bedford Road reported an unwanted patron refusing to leave. Upon arrival, officers discovered it was the same party from earlier in the day at the laundromat. Officers escorted him from the restaurant without incident and offered social services, which he declined.

02/25/2022 10:05am While on patrol on Village Lane, PO Paredes observed graffiti on a sign. A check of the area uncovered graffiti on multiple locations around Parkway Field. The investigation is continuing.

2/25/2022 3:00pm Following a call from a crisis hotline, the Westchester County Police notified this Department of a possibly suicidal individual who may be in the area of Lake Street. Responding officers searched the area with negative results. The man was located shortly thereafter at a location outside of this jurisdiction.

02/25/2022 7:12pm This Department received a call from a resident of Ledgerock Gardens, advising that there is water coming out of the manhole at the intersection of Bedford Road and Clark Street. The responding officer confirmed the situation and assessed that a Water Department response was appropriate.

02/26/2022 7:00am This Department was advised by County Fire Control of a man previously passed out but responsive at a unit within Foxwood Condominiums. Officers responded and provided first aid pending the arrival of the ambulance and paramedic. The patient was transported to the hospital via Pleasantville VAC.

02/26/2022 12:10pm The manager of a local coffee shop on Washington Avenue called to request assistance with an unwanted patron. The responding officers removed the individual from the store, and assisted the store manager with the process for filing an intent to prosecute letter should he return again.

02/26/2022 3:07pm An employee of a restaurant on Wheeler Avenue responded to Police HQ to turn in a wallet that had been found at her establishment. She had been unable to contact the owner, but officers tracked down the owner and left a message that her wallet was at the police station. Responding officers confirmed the report. PO Burns observed that the vehicle was still in drive with the operator's foot on the brake, so he positioned his patrol car directly in front of the vehicle to prevent it moving, and attempted to rouse the driver. A field interview gave officers probable cause to believe the operator was intoxicated. He was arrested and charged with Driving While Intoxicated and issued multiple traffic violations. He was transported to Police HQ, processed and held for arraignment. The vehicle was towed from the scene.

02/27/2022 12:06pm A resident of Bedford Road came to Police HQ to report that the windshield to her car had been broken while parked at her residence. A report was filed and provided to the vehicle owner for insurance purposes.

02/27/2022 12:27pm An anonymous caller reported a smoke condition at the laundromat on Wheeler Avenue. Police officers and Pleasantville Fire Department were dispatched to the location. Responding officers reported that there had been a small fire in one of the dryers, but it had been extinguished prior to their arrival. Officers maintained traffic and crowd control while Pleasantville FD ensured that the fire was completely out.

02/27/2022 5:10pm Following a report from the Westchester County Police of a motor vehicle accident with injuries and road closures on the Saw Mill Parkway, PO Casale assisted with traffic control of people exiting the Parkway in the wrong direction.
