## 02/28/2022 through 03/06/2022

The Blotters listed below represent a selection of reports made between the dates listed.

02/28/2022 7:25am An employee of a local gas station on Manville Road reports that an unknown person left without paying for gas. A search of the area for a vehicle matching the description given by the clerk produced negative results. Detectives conducted an investigation and were able to locate the vehicle and its owner.
