

BLOTTER SUMMARY

April 10 through April 16, 2023

The Blotter reports below represent a selection of reports made between the dates above.

04/10/2023 3:39pm A resident of Booth Street was on his way home and requested a police response there, as his wife was involved in a verbal dispute with employees from a private cleaning company. Upon arrival, officers learned that the dispute was over a misunderstanding regarding the wife's purse being moved by the cleaners. The officers assisted in deescalating the situation.

04/10/2023 4:35pm A resident of Broadway called to report two suspicious people taking photographs of her house. Upon further investigation, officers determined that the unknown parties were Village employees taking photos of new trees that had just been planted on the caller's property.

04/10/2023 5:41pm A village resident called to report a youth sleeping on a park bench at Roselle Park for an extended period of time. The responding officers located the girl, who appeared to be in good health when she woke up. Although no issues of concern were observed, the girl was turned over to an older family member.

04/10/2023 7:02pm A resident of Foxwoods Drive reported her sister was having difficulty breathing. The ambulance and paramedic were dispatched, and responding officers provided oxygen until EMS arrived. The patient was transported to the hospital by Pleasantville VAC.

04/11/2023 9:10am A medical alert company requested assistance at a residence on Clinton Street for a party with difficulty breathing. The responding officers provided medical assistance until EMS arrived. Upon their arrival, however, the patient refused further medical attention.

04/11/2023 10:17am Mount Pleasant Police requested mutual aid at a local residential treatment facility for an emotionally disturbed juvenile. Officers assisted in securing the scene, and the juvenile was left in custody of facility staff.

04/11/2023 12:18pm The Pleasantville Fire Chief requested enforcement of No Parking restrictions in front of Fire Headquarters on Washington Avenue. The responding officer issued a summons to one car in violation.

04/11/2023 4:25pm A resident of Hopper Street reported a school bus parked in violation near her home. The responding officer relocated the bus to a legal area to wait for the team that was practicing on the field.

04/11/2023 7:17pm A village resident called to report several bottles of alcohol left in the cemetery on Marble Avenue. The responding officer located several bottles on a bench, and they did not appear to be left as a memento but merely as trash by someone who had been drinking there. No damage was observed, and the bottles were collected and removed.

04/11/2023 9:04pm County Fire Control reported that a woman had sustained injuries from a fall outside of a restaurant on Bedford Road. The responding officers provided medical assistance until EMS arrival. The woman refused further medical attention, and did not go to the hospital.

04/12/2023 10:40am County Fire Control reported an automatic fire alarm at a business on Bedford Road. The responding officer advised that the alarm was set off due to a malfunction, and the scene was cleared by the Pleasantville Fire Department.

04/12/2023 5:09pm A local resident reported a minor motor vehicle accident on Wheeler Avenue, and the drivers of the vehicles appeared to be arguing. Upon arrival the responding officers did not observe any commotion, and facilitated the exchange of information for insurance purposes.

04/12/2023 7:54pm The central monitoring station for an alarm company reported an activated alarm at a business Bedford Road. Responding officers discovered that the alarm was set off in error by a cleaning crew that was currently inside the business.

04/13/2022 2:12am An employee of a recovery service reported conducting a repossession of a vehicle from a residence in the Village. The Desk Officer made the appropriate entry into the NY State database.

04/13/2023 8:30am The central monitoring station for an alarm company reported multiple panic alarms activated from inside a bank on Washington Avenue. The responding officers discovered the alarms were set off in error by employees.

04/13/2023 5:31pm A resident of Hopper Street reported a bus parked in the area near her home in violation of the Village Code. The responding officer assisted the driver to relocate to a legal area.

04/13/2023 7:16pm A call was received from Mount Pleasant PD requesting a Spanish-speaking officer to assist with a traffic stop on Marble Avenue. PO Garcia was dispatched to the scene, and provided translation assistance.

04/13/2023 7:42pm A resident of Academy Street reported observing an unknown male party running from his property and driving away in a brown Nissan. The caller provided a possible license plate; however, a check showed that the plate number provided did not match the description of the vehicle. Officers checked the property and canvassed the surrounding area, but the party was not located, and there were no signs of theft or damage at the caller's residence.

04/13/2023 9:22pm A resident of Manville Road came to Police HQ and requested an ambulance for severe head pain. The ambulance and paramedic were requested, and officers provided medical assistance until EMS arrival. The patient was transported to the hospital by Pleasantville VAC.

04/14/2023 7:37am A resident on Hildreth Place reported construction noise from his neighbor's home prior to 8:00am, violating the village noise ordinance. The responding officer located a crew that was setting up for the day, but they had not yet begun construction. No violation was observed, and crew was verbally reminded of the ordinance time.

04/14/2023 10:58am An employee of a day care facility on Bedford Road requested medical assistance for a child having a seizure. The ambulance and the paramedic were dispatched, and the responding officers provided medical aid until EMS arrived. The patient was transported to the hospital by Pleasantville VAC.

04/14/2023 7:09pm An employee from a local restaurant reported that the owner had detained the driver of a vehicle which had just struck a dumpster, and then caused damage to a building, on Cooley Street. Upon arrival, officers suspected the driver was intoxicated and administered field sobriety tests. Following the tests, the driver, a 57-year-old resident of Valhalla, was placed under arrest. She was transported to police HQ, processed on charges of DWI and released with an appearance ticket for a future court appearance.

04/14/2023 8:22pm A 911 call was received reporting a fight in progress at a residence on Hopper Street involving an assault, and a person threatening someone with a knife. Upon investigation, responding officers learned that following a verbal disagreement, two roommates fought, and one was injured. When family members attempted to intervene, one of the combatants threatened them with a knife. Officers arrested the perpetrator, a 29-year-old man and charged him with Menacing in the Third Degree and Assault in the Third Degree. The defendant was transported to police HQ for processing, arraigned before the Village Justice and released pending a future court appearance. Orders of Protection were issued to the two victims.

04/14/2023 9:53pm A resident of Brewster reported that his son was drunk and causing a disturbance at his ex-wife's residence on Sky Top Drive. While on scene, officers observed the son had injuries to his face subsequent to an incident with a family member. While the victim refused to press charges, a NY State Domestic Incident Report was filed.

04/14/2023 11:05pm A local youth came into police HQ to report he was assaulted by another teenager approximately 3 hours in the past. The incident was referred to a Detective/Youth Officer, who interviewed the victim and his parent. The parent did not wish to press charges, but asked to have the incident addressed. The Detective was able to follow up with the other youth and their parents, and come to an agreeable resolution in regards to the incident.

04/15/2023 2:10am Following a traffic stop on Washington Avenue, PO Cole-Hatchard determined that the vehicle was being operated with an expired registration. The vehicle was subsequently impounded and the operator was issued a citation.

04/15/2023 8:24am A village resident called to report that the elevator for the Senior Center had been out of order since 10:30pm of the night before. Responding officers checked to make sure that no parties were in the elevator, and notified the property management company. During a check of the building, officers discovered that the elevator door on the third floor was slightly ajar, and after closing it the elevator appeared to be operating normally.

04/15/2023 12:10pm A passerby reported a dispute between two parties in front of a coffee shop in Memorial Plaza. The responding officer determined that the argument was verbal in nature only, and that one party involved had left the scene. It was further discovered that the dispute was over one vehicle being parked in the crosswalk.

04/15/2023 2:00pm County Fire Control dispatched Pleasantville Fire Department to a residence on Guion Street for a gas leak due to a water condition. The responding officers assisted the Fire Department on scene as they determined there was a small leak. Pleasantville FD remained on scene for Con Edison to arrive and make necessary repairs.

04/15/2023 5:15 pm County Fire Control reported a residential fire alarm on Mountain Road. Upon arrival, officers determined that food on the stove caused the alarm, and the scene was cleared by Pleasantville FD.

04/15/2023 9:48 pm Mount Pleasant PD requested assistance with an unruly group of youths at a residential treatment facility. Officers found that the suspects had fled the scene prior to their arrival, and the school declined to pursue the matter criminally.

04/16/2023 1:01am A village resident called to report an altercation in progress at a nighttime establishment on Bedford Road. Responding officers found the scene quiet upon their arrival, but an interviewed witness provided the name of a possible victim. Upon being contacted, the victim insisted that he had not been in a fight, and that he was currently out of town. No further action was taken due to the lack of a victim and possible suspects.

04/16/2023 8:13am A resident on Hobby Street reported a loud power tool being used in violation of the Village noise ordinance. The responding officer spoke to the person on scene who was using the tool involved, and advised him of the time frames regarding power tools on weekends.

04/16/2023 12:54pm Mount Pleasant PD reported three young women had been seen running on top of the tarp covering the village pool on Lake Street. The responding officers discovered that the persons involved were gone upon their arrival, and that there was no damage to the tarp or the pool.

04/16/2023 1:38pm A call was received reporting that a female had tripped and fallen in front of a restaurant on Wheeler Avenue, sustaining injuries to her shoulder. The responding officers provided aid, and remained on scene until EMS arrival. The female was transported to the hospital via a mutual aid ambulance.

04/16/2023 3:15pm A resident of Wellington, NY reported an issue with a custody exchange at a residence on Pleasantville Road. The caller was attempting to pick up her children from her ex-spouse, but he was refusing to turn them over until it could be proven that she had the necessary child seats installed. The responding officers confirmed that the child seats were appropriate, and the exchange was completed. A NY State Domestic Incident Report was filed.

04/16/2023 4:35 pm A Hobby Street resident reported construction work going on at a neighbor's house. The responding officers reported that they advised the owner of the local ordinance and remained on scene until it was confirmed that all activity had ceased.

04/16/2023 6:56 pm A Queens resident reported that his car was rummaged through during the prior overnight hours while it was parked on Club Court. The caller stated that nothing was taken, and they were unsure if the vehicle was locked. Since the caller had already straightened up the vehicle and driven it back home, the vehicle could not be processed for evidence, but the incident was documented for the record.
