## **BLOTTER SUMMARY**

## May 29 through June 4, 2023

The Blotter reports below represent a selection of reports made between the dates above.

05/29/2023 3:54am A staff member form a local residential treatment facility requested assistance locating several AWOL students who they believed were at the Pleasantville train station and possibly on the tracks. Officers located the youths on the platform, identified them and the staff member was notified for pickup. A short time later, a 911 call was received from an employee reporting a disturbance at a gas station on Marble Avenue. Responding officers determined that the same youths had not complied with staff and then committed a larceny from the gas station. They were turned over to school staff pending further investigation, but subsequently refused to return to campus and left on a southbound train. The investigation is continuing.

05/29/2023 8:42am Several callers reported hearing what sounded like rifle shots or fireworks emanating from somewhere in the middle of the village. An officer located a group practicing for a Memorial Day Ceremony with blank rounds in their rifles while inside the cemetery on Marble Avenue.

05/29/2023 2:05pm An elderly resident in Foxwood Condominiums called 911 several times and then apologized saying there was no issue. An officer was dispatched to check on her welfare, and ascertained that she was having an issue with a pre-programmed phone. The officer spoke with a health aide on premise and helped to rectify the problem.

The responding officers reported locating the student near the entrance on the train station. The student was holding a rock in their hand and threatening to break the windows of the transport van, but officers were able to convince the student to put down the rock. The student was transported to the hospital by Pleasantville VAC with an officer on board for security.

05/29/2023 6:43pm The central monitoring station for an alarm company reported an automatic fire alarm at a residence on Court Street. The responding officers reported that the alarm was set off by burning food. The scene was cleared by Pleasantville FD.

The responding officers located them at different locations in the Village and they were arrested. Mount Pleasant Police officers assisted in securing the scene while the youths were transported to HQ. They were charged with Robbery in the Second Degree, or Petit Larceny depending on their involvement, and returned to staff members with appearance dates for Family Court. The investigation is continuing at this time.

05/30/2023 12:45pm A resident of Peekskill reported she had just been struck by a vehicle while walking across Bedford Road at the intersection with Marble Avenue. Responding officers determined that she had suffered minor injuries, so the ambulance and the paramedic were dispatched. The driver of the vehicle remained on scene and assisted with the completion of a NY State Accident Report. The pedestrian was transported to the hospital by Pleasantville VAC.

A man described as an older white male with a small build, wearing a black jacket and a beige hat, had come into the store and requested a pack of cigarettes. When the clerk put the cigarettes on the counter, the thief grabbed them and fled eastbound on Bedford Road. Responding officers canvassed the area but were unable to locate the suspect. The incident is currently under investigation.
