

BLOTTER SUMMARY

May 22 through May 28, 2023

The Blotter reports below represent a selection of reports made between the dates above.

05/22/2023 11:21am A staff member of a residential treatment facility on Broadway reported a group of youths in the roadway causing a disturbance. Upon their arrival, responding officers noted no disturbance, but a large group of AWOL students were being followed by staff members. The youths boarded a Bee Line bus and departed the area.

05/22/2023 4:36pm A resident of Briarcliff reported being involved in an ongoing road rage incident that began on Bedford Road near Pace University. A short time later, a second call reported the incident is continuing on Wheeler Avenue and the suspected vehicle involved is fleeing the area. Responding officers located the vehicle and performed a traffic stop. All parties involved were interviewed, and it was determined that no crime had been committed, so a report was filed.

05/22/2023 7:00pm A village resident came to police HQ to report that they were scammed out of \$500 on ZELLE while trying to purchase concert tickets online. Once the money was sent, the victim never received the tickets. The matter is currently under investigation.

05/22/2023 9:23 pm A resident of Ardsley reported a man who may be intoxicated attempting to drive away from a business on Marble Avenue. Responding officers located the individual across the street, and determined he was not fit to drive. A safe ride was arranged for him back to his residence in Valhalla.

05/23/2023 11:10am An employee of a child care facility on Bedford Road reported an odor of smoke. Pleasantville FD was dispatched. Upon arrival, all children were evacuated from the building for safety and the responding officer assisted to determine that the alarm was set off by the A/C unit. Scene was cleared by Pleasantville FD.

05/23/2023 11:54am A resident of Washington Avenue called to report that at some point over the last several days, someone had stolen the catalytic converter from her vehicle. The responding officers completed the initial investigation, and checked the area for surveillance cameras. The incident is currently under investigation.

05/23/2023 2:39pm A resident of Washington Avenue reported a smoke condition and possible structure fire at his home, and that there was a woman and a baby inside the home. Pleasantville FD was dispatched, and responding officers cleared the home, which was engulfed in smoke. Investigation determined that the heavy smoke was a result of food left on the stove. Pleasantville FD secured the scene, and several civilians and responding officers were treated by Pleasantville VAC and paramedics for smoke inhalation. The Building Inspector was notified and responded to check the condition of the building.

05/23/2023 6:02pm Staff from a local residential treatment facility reported that three residents of the facility had entered the Village Pool at Nannyhagan Park. The responding officer gained access to the locked gate, and assisted staff to retrieve the girls and bring them back to campus.

05/23/2023 6:02pm A driver on Broadway reported a young woman screaming for police assistance. The responding officer located the woman, with whom he is familiar, determined she was not in danger and helped her to regulate her emotions. Her parents were contacted, and the family was reunited at the scene. The Mobile Crisis Response Team was notified for follow-up in the future.

05/23/2023 9:40pm The father of the girl in the previous call reported that his daughter had gone missing. Surrounding agencies were notified and additional resources were requested to assist in locating her. A short time later, she walked into Police HQ and was eventually reunited with her family.

05/24/2023 5:17am A Life Alert operator requested a lift assist of an elderly party who was having trouble exiting his wheelchair at his residence in Foxwood Condominiums. The responding officers were able to assist the man involved.

05/24/2023 9:18am A resident on Bedford Road reported the crew of landscapers his neighbor had employed was utilizing a gas-powered leaf blower in violation of the Village ordinance. The crew was gone upon the arrival of the officers.

05/24/2023 11:12am An employee of a gas station on Pleasantville Road called to report that several youths were inside stealing items. The caller had detained one of the four youths involved, and responding officers were able to locate and secure the others. They were

all transported to Police HQ for processing, and due to the circumstances of the incident, each was charged with Robbery 2nd Degree as a juvenile. Appearance tickets were issued for appearance in Family Court at a later date, and they were released back to the custody of staff from their residential treatment facility.

05/24/2023 3:42pm Multiple callers reported a possible domestic dispute between a father and his young daughter on Marble Avenue. Upon the responding officers' arrival, the father had left and only the daughter and her mother were on scene. While the officers were interviewing both parties, the father returned and had to be restrained by officers. The father, a 66-year-old resident of the Cortland Manor, was placed under arrest and transported to Police HQ for processing. He was charged with Disorderly Conduct, two counts of Endangering the Welfare of a Child, and Obstructing Governmental Administration, and arraigned before the Village Justice, who issued a Temporary Order of Protection. He was released on his own recognizance for a court appearance at a later date.

05/24/2023 5:58pm Staff members from a residential treatment facility requested assistance retrieving three youths who had entered the Village Pool on Lake Street. Responding officers were able to remove the youths from the pool and return them to staff.

05/24/2023 7:40pm A resident of Sunnyside Avenue reported a man outside of a church on Bedford Road attempting to make unwanted contact with parishioners. The responding officers interviewed and identified the male, who was unhoused, and he left the area.

05/24/2023 8:35pm A resident on Hopper Street reported that he had returned home and found his brother, with whom he lives, unresponsive. The ambulance and the paramedic were dispatched, and responding officers assisted as the 58-year-old man was pronounced dead at the scene. A detective was dispatched to the scene to continue the investigation, and the County Medical Examiner's Office was notified.

05/24/2023 9:48pm A Life Alert Operator requested help for a lift assist at a residence on Clinton Street. The responding officers determined that the party had not sustained any injuries, and were able to render assistance.

05/25/2023 12:21am The central monitoring station for a private alarm company reported a burglar alarm activation at a residence on Brookview Drive. The responding officers observed an open garage door upon their arrival, so they entered and checked the home. They found the residence to be secure with no signs of criminal activity, and re-secured the open door before leaving the scene.

05/25/2023 2:42pm A resident of Brooklyn reported that his mother, who lives on Ashland Avenue, had been the victim of an attempted scam. After receiving a "fraud alert" from "Amazon", the woman was instructed to purchase approximately \$20K in gift cards. Upon discovering the intended transaction, the son was able to cancel the gift cards, so no money was actually lost. The incident is currently under investigation.

05/25/2023 6:15pm A village employee reported a group of young people had jumped the fence in Nannahagen Park and were on the deck of the Village Pool. Responding officers assisted staff from their residential treatment facility to return the youths safely to campus.

05/25/2023 6:42pm A resident of Stanley Street requested police assistance for a lift assist for his elderly mother. The responding officers were able to assist the woman back to her feet without incident.

05/26/2023 7:01am The central monitoring station for an alarm company reported an automatic alarm at a business on Campus Drive. The responding officers reported that alarm was set off in error by an employee.

05/26/2023 11:36am A resident of Bedford Road reported a lawn crew using a gas-powered leaf blower in violation of the village ordinance. The lawn crew was advised by the responding officer of the ordinance, and they agreed to cease its use.

05/26/2023 12:17pm Mount Pleasant PD reported a dispute in progress on Broadway between a female student and staff members from her residential treatment facility. The responding officers assisted in de-escalating the situation and she eventually agreed to return to campus.

05/26/2023 4:23pm A resident of Bedford Road called to report that a guest had fallen in her apartment and sustained injuries. The ambulance and the paramedic were dispatched, and responding officers provided medical assistance until EMS arrival. The patient was transported to the hospital by Pleasantville VAC.

05/26/2023 6:05pm A Life Alert operator requested Police and EMS respond to a residence in Foxwood Condominiums for an elderly party who had fallen and sustained an injury. The responding officers provided medical assistance until EMS arrival. The patient was transported to the hospital for further medical treatment by Pleasantville VAC.

05/26/2023 6:30pm An employee at a business on Pleasantville Road reported a man acting aggressively towards employees. The responding officers canvassed the area and located a man fitting the description provided in a convenience store. When interviewed, he admitted he had gotten into a confrontation, but stated it was because he had been wrongly accused of shoplifting. The man was identified and left to catch a train.

05/26/2023 11:50pm An employee of a business on Marble Avenue reported an unknown person sitting in a car in their parking lot for an extended period of time. The car was gone upon the officer's arrival, and a check of the building for signs of suspicious activity was negative.

05/27/2023 5:00am Despite posted warnings, one car was towed from the Memorial Plaza parking lot for violation of parking restrictions for the Farmer's Market.

05/27/2023 11:00am A resident of Leland Avenue reported an Amazon truck had just struck her parked vehicle and left the scene. Officers canvassed the area for the truck, but were unable to find it. Witnesses were interviewed and an investigation was initiated. A NY State Accident Report was filed.

05/27/2023 9:15pm An employee of a local restaurant on Marble Avenue called 911 to report a patron experiencing an allergic reaction. EMS was dispatched, and responding officers provided medical assistance pending their arrival. The patient was transported by to the hospital by Pleasantville VAC.

05/27/2023 9:35pm County Fire Control reported they were dispatching Pleasantville FD to an automatic fire alarm at a residence on Washington Avenue. The responding officers assisted the fire department to determine that the alarm was set off in error by burning candles.

05/28/2023 2:59am The central monitoring station for an alarm company reported an automatic alarm at a residence on Seneca Lane. The responding officers checked the exterior of the residence, and found it secure.

05/28/2023 10:38am A resident of Bedford Road reported that her cat had been stolen while she was in the hospital. The responding officers interviewed her and determined the cat was in possession of a former friend who lives in the Bronx, and he is refusing to return it. A message was left on that person's voicemail seeking more information.

05/28/2023 1:59pm A resident of the Village reported she was having an argument with her husband on Wheeler Avenue. The responding officers de-escalated the situation, interviewed both parties and determined no violations had been committed. A NY State Domestic Incident Report was filed, and the couple were able to peacefully leave with each other. The Mobile Crisis Response Team was notified for follow up with both parties.

05/28/2023 2:31pm A resident of Foxwood Drive requested EMS for her husband, who was having difficulty breathing. The ambulance and the paramedic were dispatched, and responding officers provided medical attention and supplied oxygen until EMS arrival. The party was transported to the hospital by Pleasantville VAC.

05/28/2023 4:23pm A resident of Seneca Lane reported youths not doing anything wrong, but AWOL from a residential treatment facility, in her neighborhood. The woman was informed that the students may not, in fact, be AWOL, but she was insistent. The Desk Officer contacted the school and officers checked the area, but no students were reported as AWOL.
