## **BLOTTER SUMMARY**

## June 12 through June 18, 2023

The Blotter reports below represent a selection of reports made between the dates above.

06/12/2023 7:24am A resident of the Country Club requested medical assistance for her husband who was passing out. The ambulance and the paramedic were dispatched, and responding officers provided medical assistance until EMS arrival. The patient was transported to the hospital by Pleasantville VAC.

06/12/2023 1:23pm A resident of the Sherman Park area of the Village came to Police HQ to report an ex-boyfriend has been texting her and visiting her without permission. The woman did not wish to pursue charges, but asked for assistance in getting him to stop. The reporting officer contacted the ex-boyfriend, and advised him against any further interactions. He stated that he understood, and would not reach out to her again.

The resident received notification that the package had been delivered, and when they returned home later in the day, the package was gone. The investigation is ongoing at this time.

After establishing trust with the young man on social media, the perpetrators were able to access his bank accounts and transferred out \$900.00. The bank was in the process of reversing the charges, but the woman requested a police report be filed. The incident is currently under investigation.

The responding officers advised that the dispute was only verbal, and all parties had been separated. The Mobile Crisis Response Team was dispatched to the residence to offer additional counseling services to the family. A Domestic Incident Report was filed.
