

## **BLOTTER SUMMARY**

**June 19 through June 25, 2023**

The Blotter reports below represent a selection of reports made between the dates above.

06/19/2023 8:03am The central monitoring station for an alarm company reported an automatic fire alarm at a residence on Manville Road. The responding officer reported that the alarm was set off by steam from the shower.

06/19/2023 10:42am County Fire Control reported a female experiencing abdominal pains at a local business on Marble Avenue. Officers and EMS were on scene and administered basic first aid. The patient was transported to the hospital by Pleasantville VAC.

06/19/2023 12:50pm A group of youths came into Police HQ to report an incident that had just occurred in Memorial Plaza. The youths reported that they were approached by a man they did not know who yelled at them to get away from his friend's car. The youths further reported that the man had then poked one of them in the ribs, and then left the scene. Officers were able to locate the suspect, who stated the boys were swinging a traffic cone near the car, so he merely asked them to stop, and he denied ever touching anyone. Statements were taken from everyone involved and the investigation is continuing.

06/19/2023 1:01pm An operator at the Bee Line bus company reported a passenger intoxicated and sleeping on a bus stopped on Bedford Road. Responding officers assisted the man off the bus and onto the correct bus to get him back home to Ossining.

06/19/2023 7:45pm A neighbor reported a dispute in the driveway of a residence on Washington Avenue. Responding officers learned that guests of a tenant had a verbal argument in the driveway and were now leaving. No crimes were committed and the parties went on their way.

06/19/2023 9:59pm A resident of Vanderbilt Avenue reported a woman climbing onto the fence overlooking the train tracks. Responding officers interviewed her and determined she was not a threat to herself and was waiting to pick up her daughter nearby.

06/19/2023 11:09pm A Village resident reported a man on Manville Road who may be in need of assistance. Officers responded and located a man who was unhoused resting in the area before moving on to a new location. Outreach and medical services were offered by the officers, but he declined.

06/20/2023 12:05pm A resident of Briarcliff came to Police HQ to turn in a bag containing a camera she had found on Wheeler Avenue. The owner could not be located, so the camera was vouchered and secured for safekeeping.

06/20/2023 1:09pm A resident of Croton on Hudson called 911 to report being involved in a verbal dispute in a parking lot on Marble Avenue. The responding officer deescalated the situation and determined the dispute was over a minor traffic accident and a small amount of damage done to a parked vehicle. Once everyone was calm, both parties involved agreed to handle the matter privately.

06/20/2023 4:48 pm A resident of Bedford Road reported that his neighbor's son, who is autistic, had left the house without his mother's knowledge. A description was provided, and responding officers located the missing youth a short distance away while in route to the residence. The young man was brought back to the residence and mother and son were reunited.

06/20/2023 7:31pm While conducting security in the Court Room, a Pleasantville detective requested an ambulance for a person in attendance who had a seizure. EMS was dispatched, and officers kept him safe and comfortable while awaiting their arrival. The patient was transported to the hospital by Pleasantville VAC.

06/20/2023 11:38pm Ossining PD requested a welfare check on one of their residents who was posting on social media about self-harm, and was believed to be staying with a friend in Pleasantville. After a brief investigation, the party's location was confirmed, and officers determined that the man did not present a danger to themselves or others. Multiple county sponsored services were offered, but the man declined any further assistance.

06/21/2023 12:20pm A resident of Pierce Drive reported a car parked blocking a fire hydrant in the area of her home. The responding officer was able to locate the vehicle owner and the vehicle was moved and parked legally.

06/21/2023 8:48pm County Fire Control reported a pedestrian struck by a vehicle on Broadway in the area of Seneca Lane. The responding officers determined that no one had been struck by a vehicle, but that a resident of a local treatment facility had damaged school property and then laid down on the side of the road. Officers assisted staff to return the student back to campus.

06/22/2023 10:52am Staff at the Clinton Street Center reported people possibly stuck in the elevator. The responding officers confirmed two parties were in the elevator, and assisted maintenance personnel to open the elevator door and remove those stuck inside.

06/22/2023 3:26pm An employee of a business on Washington Avenue requested EMS for a customer complaining of abdominal pain. The ambulance and paramedic were dispatched, and responding officers provided assistance until they arrived. The patient was transported to the hospital by Pleasantville VAC.

06/22/2023 4:47pm Multiple callers reported a physical altercation on Broadway. Upon arrival, responding officers discovered no altercation, but staff from a residential treatment facility were attempting to calm down an emotionally disturbed student. Officers assisted Pleasantville VAC in escorting the student to the hospital for further evaluation.

06/22/2023 5:39pm A resident of Pleasantville reported two girls on the train tracks in the area of Sunnyside Avenue. The responding officers canvassed the area with negative results. Witnesses were located, who confirmed that the youths who were on the tracks had left the area.

EMS was dispatched, and the responding officers found the young man awake and alert upon their arrival. Officers provided medical assistance, and the patient was transported to the hospital by Pleasantville VAC.

Officers attempted to speak with the downstairs neighbor, but he refused to come to the door. Officers reported the banging had stopped and the situation was corrected for the time being.

The ambulance and the paramedic were dispatched, and responding officers provided medical assistance pending their arrival. The patient was transported to the hospital by Pleasantville VAC.
