

BLOTTER SUMMARY

June 26 through July 2, 2023

The Blotter reports below represent a selection of reports made between the dates above.

06/26/2023 6:37am The central monitoring station for an alarm company reported an automatic burglar alarm activation at a residence on Treetop Lane. The responding officers determined that the alarm was set off in error by the homeowner.

06/26/2023 11:00am County Fire Control reported they were dispatching EMS to Vanderbilt Avenue for a man with back pain. The responding officers provided assistance until EMS arrival. The party was transported to the hospital by Pleasantville VAC.

06/26/2023 2:00pm A resident of Vanderbilt Avenue reported an illegally parked truck blocking the roadway on Depew Street. The responding officer located the vehicle, which was making a local delivery, and ensured that it was moved.

06/26/2023 2:22pm An employee at a business on Bedford Road reported an elderly woman at her business who appeared disoriented and was requesting police assistance. Upon arrival, the responding officer determined that the woman was trying to get to White Plains Hospital, but was nervous about driving in the rain. The officer facilitated a taxi for her.

The man was transported to Police HQ for processing and brought before the Village Justice for arraignment. Following that, he was transported back to the County Jail.

A resident of a local residential treatment facility had stopped a bus, got on, and was now refusing to get off. The bus was stopped on Broadway, obstructing traffic. Responding officers learned that the girl had made threats of self-harm and did not want to go to the hospital. Eventually, she was removed from the bus and transported to the hospital by Pleasantville VAC with an officer on board.

06/27/2023 7:27 pm A nearby resident reported hearing screaming and yelling in the vicinity of Broadway and Country Club Lane. The responding officers found the staff of a residential treatment facility attempting to convince an AWOL student to return to campus. The officers interceded, and were able to coax the student back to campus and have staff assume supervision.

06/27/2023 8:17 pm A resident on Brookfield Place called to report a carbon monoxide alarm activation at their residence. The responding officer confirmed the residents had evacuated the premise and were showing no signs of impairment. The Pleasantville Fire Department responded and confirmed positive readings. The scene was cleared by Pleasantville Fire after the carbon monoxide levels returned to normal.

06/28/2023 11:40am A village resident came to police HQ to have a Family Court Temporary Order of Protection served to another resident. An officer was able to make contact with the respondent, who came to Police HQ later in the day to be served.

06/28/2023 2:41pm A resident of Thornwood came into police HQ to report the loss of a passport packet that had been dropped off at the Pleasantville Post Office. The responding officer filed a report, and party was advised to follow up with the Postal Inspector.

06/28/2023 4:05 pm A resident of Hopper Street reported multiple vehicles double parked and obstructing vehicular flow on the street in front of their house. Upon arrival, the responding officer observed no violations and that traffic was moving sufficiently.

Officers checked the surrounding area for the transformer in question, but no anomalies or hazardous conditions were found. The caller was advised to contact Con Edison to address the power outage.

The responding officers were directed to the woman, who was nauseous and feeling faint. The ambulance and the paramedic were dispatched, and officers administered oxygen while waiting for EMS arrival. The patient was transported to the hospital by Pleasantville VAC.

07/01/2023 5:00am One vehicle was towed from the Memorial Plaza parking lot due to violating the No Parking restrictions for the Pleasantville Farmers Market.

07/01/2023 1:19pm A Mercedes Benz service representative reported a vehicle emergency button activation from Marble Avenue. Responding officers located the vehicle owner, and it was determined that the emergency button was activated accidentally.

Upon arrival, responding officers found approximately a dozen youths inside the enclosed area of the pool, acting rowdy. Officers removed them from the pool and returned them to the custody of staff. The area was re-secured and no damage to village property was found.

The students were eventually escorted back to campus, as they continued to walk in the roadway and create noise.

Responding officers located the woman's neighbor, who had fallen and was in need of a lift assist. Officers helped her up and determined she did not need further medical care.

The paramedic and the ambulance were dispatched, and responding officers found the woman conscious upon their arrival.
