

## **BLOTTER SUMMARY**

**July 24 through July 30, 2023**

The Blotter reports below represent a selection of reports made between the dates above.

07/24/2023 3:18am The central monitoring station for an alarm company reported an activated alarm at a facility in Memorial Plaza. Responding officers checked the exterior of the building and found the location secure.

07/24/2023 10:43am A resident of Charlmont Drive reported that his vehicle had been entered and items removed. The caller stated the crime had occurred sometime in the past 24 hours. An officer responded and conducted a preliminary investigation. A larceny report was filed, and the investigation is ongoing.

07/24/2023 3:55pm A resident of Depew Street reported a vehicle parked in the fire lane on Vanderbilt Avenue. The responding officer discovered that the vehicle had left prior to his arrival.

07/24/2023 5:08pm A resident of the Village reported her husband, who has Alzheimer's, went out to get the mail a short time ago and has disappeared. The responding officers canvassed the area with negative results, so surrounding agencies were notified. A short time later, New Castle PD located the subject in their jurisdiction, and the man was transported home by Pleasantville officers.

07/24/2023 8:12pm An employee of a convenience store on business on Marble Avenue reported a disturbance at the store. Responding officers determined that a young woman had been in the process of attempting to steal merchandise when she was detained by an employee and another customer. The store owner declined to press charges, and the young woman was identified and returned to the custody of staff from her residential treatment facility.

07/24/2023 9:33pm A resident of Ashland Avenue reported a person walking eastbound on Bedford Road in the lane of traffic. The responding officer located the woman, who declined assistance or to provide pedigree information. She entered sidewalk and then boarded a Bee-Line bus.

07/25/2023 8:49am A resident on Manville Road called to report that two truck tires were in her front yard, and she does not know where they came from or what to do with them. An officer responded and ascertained that the tires appeared to have been damaged and may have fallen off a tractor trailer and rolled to their location. DPW was contacted to assist with removal.

07/25/2023 2:45pm Fire Control reported that they had received a call from a man on Marble Avenue threatening self-harm. Responding officers located the man and deescalated the situation. The patient was transported to the hospital by Pleasantville VAC.

07/25/2023 7:15pm A resident of Ossining reported multiple vehicles parked in violation of posted signs in front of a business on Cooley Street. The responding officer issued one summons.

07/26/2023 1:07am A resident on Skytop Drive requested a lift assist for her mother, who had fallen and could not get up. The responding officers determined that the woman had not sustained any injuries, and they assisted in getting her up.

07/26/2023 10:20am Westchester County PD requested Pleasantville officers to assist on a motor vehicle stop on Cooley Street with three people in the vehicle. A Spanish speaking officer was requested to assist with translation. Officers provided backup and translation services, and the vehicle was eventually impounded by County PD.

07/26/2023 11:40am The central monitoring station for an alarm company reported a commercial fire alarm at a business on Marble Avenue. The responding officers assisted FD personnel to determine that the alarm the result of a malfunction. The scene was cleared by Pleasantville FD.

07/26/2023 11:41am A village resident came into police HQ to report that his Facebook profile had been hacked and he was no longer able to access it. Further, the hacker then posed as the complainant requesting people to sign up to a financial program. The resident is not out any money at this time, but wanted to make a report. The incident is currently under investigation.

07/26/2023 12:50pm A manager at a local business reported a dispute himself and another employee, in which the employee threw coffee at him. The responding officers

interviewed both parties involved, as well as witnesses. In the end, the caller declined to press charges, and refused any medical attention.

07/26/2023 3:02pm A resident on Foxwood Drive came to police HQ to report that an unknown party had taken plants and equipment from her garden. Video showed that the theft had occurred approximately two weeks prior. A preliminary report was prepared, and the video footage was forwarded to the Detective Division for further investigation.

07/26/2023 6:40pm A resident of Tarrytown reported that her vehicle had been struck by another vehicle while it was parked in a commercial parking lot on Bedford Road, and that the second vehicle had left the scene. A witness provided police with the license plate of the suspect vehicle, and a canvass of the area was negative. The accident is currently under investigation, and a NY State Accident Report was filed.

07/27/2023 2:55am A resident of Orchard Street reported a dog continuously barking and whimpering somewhere outside her home. The responding officers canvassed the surrounding area, but did not locate the dog.

07/27/2023 10:20am Officers were requested to assist Adult Protective Services (APS) with a welfare check called in by a family member at a residence within the village. Upon arrival, responding officers attempted to get the man to come to the door, but he refused. Communication was established through the door, and the resident stated that they were fine, and requested that all parties leave their property. Based on the conversation with the resident, officers and APS workers did not deem the party to be a danger to himself. The officers and APS left the scene without incident.

07/27/2023 3:20pm Mount Pleasant PD reported a possible disabled truck on Marble Avenue near Booth Street. The responding officers determined that the truck merely needed assistance in turning around in the street. Once the officers were able to assist the driver in getting the truck turned around, he went on his way.

07/27/2023 6:12 pm A resident of Grove Street reported a vehicle parked in the roadway near her home, away from the curb. The responding officer determined the vehicle was not obstructing traffic, and had it moved to a better location.

07/27/2023 8:18 pm A student from Pace University reported she had lost her Apple Watch in the area of the bus stop in Memorial Plaza. A report was made to document the lost property. A few days later, an employee of a local restaurant came to Police HQ to turn in the watch, which she had found. The owner was contacted and retrieved her property.

07/27/2023 9:04 pm An woman came into police HQ to report her girlfriend was unconscious at the bus stop on Bedford Road near Wheeler Avenue. Upon arrival, the responding officers determined that the woman had regained consciousness, but was suffering from a medical condition. EMS was dispatched, and officers provided basic first aid pending their arrival. The patient was transported to the hospital via Pleasantville VAC.

07/28/2023 11:40am A Countywide Hotline message was received reporting a stolen vehicle pursuit southbound on the Saw Mill River Parkway towards Pleasantville. The vehicle was disabled by Westchester County PD near Marble Avenue, and the driver of the vehicle fled on foot into Graham Hills Park. Officers from Pleasantville PD, Mount Pleasant PD, Westchester County PD, and NY State Police set up a perimeter around the area, and K9 and Aviation assets were deployed. The suspect was eventually found and taken into custody near the end of Pollywoggle Lane.

07/28/2023 2:04pm A resident of South Salem reported that they had just struck a parked vehicle on Pleasantville Road. The responding officer was able to locate the owner of the parked vehicle, and assisted in both parties exchanging information.

07/28/2023 7:48pm A resident of a local apartment complex reported her neighbor was yelling for help in the common hallway. Responding officers located the man and learned he was yelling because his phone had died. Officers were able to assist him to plug the phone into a charger.

07/28/2023 8:13pm A resident of White Plains turned in a purse he had found on Bedford Road. Officers attempted to return the purse to her residence, but when she was not at home, a voice mail was left informing her that it was at the police station and logged into safekeeping. The woman came to the Police Department a short time later to retrieve it.

07/29/2023 2:47pm A resident of Chappaqua reported a disturbance on Manville Road near this intersection with Washington Avenue. Responding officers discovered a scuffle

between a mother and her adult son as she attempted to restrain him during a period of emotional dysregulation. EMS was dispatched, and officers attempted to keep the man stable pending their arrival. The patient was transported by Pleasantville Ambulance to the hospital.

07/29/2023 6:32pm A village resident reported an unlocked door at a closed business on Cooley Street. After determining that nothing was amiss, responding officers contacted the owner of the store, who returned to resecure the front door.

07/29/2023 7:22pm A call was received from an alarm company reporting a residential alarm. The responding officers found an open door and checked the residence, but found no signs of forced entry or criminality. They determined that the door was blown open by storm winds, and re-secured it upon leaving.

07/29/2023 9:16pm A resident of Roselle Avenue reported an unknown vehicle idling in a parking spot. The responding officers located the vehicle and spoke to the driver, who was a resident of the building sitting in the car talking with a friend.

07/30/2023 3:45am This Department was notified that a vehicle operated by a man from Virginia wanted for felony assault and suicidal ideologies may be in the area. Officers located the vehicle on Marble Avenue and secured the driver. Two (2) handguns were retrieved from the scene, and the man was placed under arrest. He was transported to Police HQ and processed. Following his arraignment in front of the Village Justice, he was remanded to Westchester County Jail.

07/30/2023 7:00am A resident of Sunnyside Avenue reported a vehicle parked in the middle of Martling Avenue, obstructing traffic flow. Officers were unable to locate the driver and owner, so the vehicle was impounded to a local tow yard. When the owner responded to Police HQ later that day to report his vehicle missing, he was given the release form necessary to recover his vehicle. The vehicle had apparently slipped out of gear and rolled, unoccupied, to the location from which it was recovered.

07/30/2023 9:25am A resident of Ridgeview Drive reported very low water pressure at their residence. The water department was notified and upon responding with an officer, it was deemed that a power surge had disabled the system. Water Department personnel reset the system and restored service.
