

BLOTTER SUMMARY

July 3 through July 9, 2023

The Blotter reports below represent a selection of reports made between the dates above.

07/03/2023 12:00am A resident of Vanderbilt Avenue requested assistance for his wife, who was not feeling well. The ambulance and the paramedic were dispatched, and responding officers provided first aid pending their arrival. The patient was transported to the hospital via Pleasantville VAC.

07/03/2023 8:23am A resident of Pleasantville Road reported a gas-powered leaf blower being operated by someone on their street. The officer who responded located the person using the leaf blower and advised them of the ordinance.

07/03/2023 2:19pm A resident of Washington Avenue reported his upstairs neighbor was making excessive noise. Officers spoke with all parties involved and deemed the noise was not excessive but basic apartment sounds that come with shared floors, ceilings and walls. Everyone involved was advised of appropriate ways to mitigate the issues involved.

07/03/2023 8:20pm An operator from a central monitoring company reported a medical alert activation from a resident on Tompkins Avenue, with no answer on the callback. Officers determined that there was no problem at the home, and that the alarm was accidentally activated.

07/03/2023 9:55pm A resident on Washington Avenue called to report fireworks being used in the area of Sarles Lane. The responding officers canvassed the area, but did not see or hear any fireworks.

07/04/2023 1:28am Mount Pleasant PD reported one of their officers was out at a convenience store in the Village and was approached by an intoxicated man looking for assistance. Responding officers were able to converse with the individual in Spanish, and determined he had questions regarding an upcoming issue at Village Hall.

07/04/2023 3:25am A local gas station attendant reported they needed police assistance but could not specify due to language barrier. Once on scene, officers determined the issue was with an elderly customer from Long Island who had fallen and was disoriented. An ambulance was called and the patient was transported to a local hospital. His vehicle was safely parked, and Nassau County PD was requested to do a family notification.

07/04/2023 10:02am A resident of Washington Avenue requested medical assistance for her husband, who may have had a stroke. Responding officers administered oxygen while awaiting the arrival of the ambulance and the paramedic. The patient was transported to the hospital via Pleasantville VAC.

07/04/2023 7:22pm A resident of Manville Road reported a dispute over custody of her son with her ex-husband. Responding officers were able to resolve the disagreement and referred both parties to family court for further guidance. A NY State Domestic Incident Report was filed.

07/04/2023 7:54pm Multiple callers reported a man stealing items from a local convenience store and striking the clerk. Responding officers located the suspect being restrained by a bystander a short distance away and took him into custody. The defendant, a 44-year-old man from Thornwood, was transported to Police HQ, processed and charged with Robbery in the Second Degree and Assault in the Third Degree. An Order of Protection was issued.

07/04/2023 9:10pm A resident of Pierce Drive reported loud fireworks coming from a neighbor's house. The responding officer located the source on Washington Avenue and advised the owners of the local ordinances regarding their activity. The owners ended their activity for the night.

07/05/2023 2:45pm A Manville Road resident requested a fire department response for a carbon monoxide detector activation. Officers and the Pleasantville Fire Department responded, and it was determined that the alarm was a malfunction.

07/05/2023 4:55pm A resident of Church street reports hearing loud "gunshot" like banging sounds. Responding officers checked the area and discovered the source as Con Edison doing powerline work in the neighborhood.

07/05/2023 8:00pm An employee of a business in Memorial Plaza reported an unknown female stealing property and fleeing the premises. Responding officers took a description and searched the area, locating a suspect on Wheeler Avenue and recovering the stolen merchandise. The business, however, declined to press charges.

07/05/2023 11:35pm County Fire Control reported they were dispatching EMS to a report of an unconscious person at a residence on Marble Avenue. Once on scene, responding officers were directed by family members to a bathroom, where they found the man awake but heavily intoxicated. The paramedic and the ambulance arrived, and the patient was transported to the hospital by Pleasantville VAC.

07/06/2023 7:23am A resident on Saratoga Avenue reported a vehicle that had been parked on the street for several days. The responding officer advised that the vehicle was legally registered to a woman from Yorktown Heights and not parked in violation of any posted restrictions.

07/06/2023 4:01pm Security personnel from a local business reported a car parked on private property for an extended period of time. Responding officers located the vehicle and spoke to the driver, who was waiting to pick up his wife from work.

07/06/2023 6:32pm The manager of a restaurant on Wheeler Avenue reported a man harassing patrons. Upon arrival, responding officers located the man sitting in the park. When interviewed, he stated he was waiting for the train, and left the area to go to the railroad platform.

07/06/2023 8:20pm A Village resident reported an odor of gas inside her home. Officers and the fire department responded and found the stove had been left on while no one was home. After ventilating the home, FD personnel insured no gas was detected.

07/07/2023 8:46am An employee from a business on Bedford Road called 911 to report a co-worker having a diabetic emergency. The ambulance and the paramedic were dispatched, and officers and EMS personnel administered basic first aid to the patient. After receiving treatment on scene, the patient refused further medical treatment.

07/07/2023 11:57am County Fire Control dispatched EMS to a home for an elderly man with an altered mental status. Officers and EMS rendered aid to the patient, and he was transported to the hospital by Pleasantville VAC.

07/07/2023 2:07pm A resident of Edgewood Avenue reported a suspicious vehicle parked on the corner of Grove Street and Edgewood Avenue for several days. The responding officer ensured that the vehicle was not parked in violation, and the Parking Enforcement Officer was advised of the vehicle to ensure that parking time limits were being enforced.

The ambulance and the paramedic were dispatched, and the responding officers provided first aid until EMS arrival. The patient was transported to the hospital by Pleasantville VAC.

Responding officers administered first aid to stop the bleeding, the ambulance crew dressed the wound upon their arrival. The woman refused further medical attention.

07/08/2023 11:02am An alarm company operator called to report an alarm activation emanating from the front entrance of the business on Irvington Street. The responding officers checked the outside of the building, and determined it was secure.

07/08/2023 1:21pm An operator from Liberty Bus Lines reported a disturbance on Bedford Road between a bus driver and an irate passenger who was trying to force their way onto the bus carrying a motorized scooter. The responding officer reported that the passenger agreed to get off the bus.

07/08/2023 4:39pm A Mohegan Lake resident requested assistance because they had locked their keys in their vehicle on Irvington Street. The responding officer was able to get into the vehicle without incident.

07/08/2023 8:25pm An officer assigned to the Pleasantville Music Festival reported a festivalgoer who appeared to be suffering from dehydration. The party was evaluated by EMS, and transported by ambulance to the hospital for further care.

07/09/2023 2:03am Officers were dispatched to the village pool after a 911 caller reported approximately 10 to 12 juveniles trespassing inside the pool area. Officers arrived on scene and observed the juveniles fleeing into the woods. Mount Pleasant and DEP police assisted with a canvass with negative results. No damage was observed.

07/09/2023 5:26am Mount Pleasant PD requested mutual aid for a group of students attacking staff at a residential treatment facility in their jurisdiction. Officers remained on scene until such time as the situation was under the control of staff and police.

07/09/2023 7:05am A village resident requested assistance for a family member who was in mental distress and unable to calm down. The responding officers determined that woman in question had been taking "diet pills" purchased online, which appeared to be having an adverse effect. The patient was transported to the hospital by a mutual aid ambulance.

07/09/2023 12:53pm A village resident reported that her adult son was attempting to force his way into her residence. Responding officers de-escalated the situation and interviewed both parties. It was determined that the dispute was over the young man's finances, which his mother controls. The son was upset over a perceived discrepancy, but he calmed down once the situation was explained to him.

07/09/2023 4:22pm A village resident came to Police HQ to report being yelled at by a woman she does not know. The young woman reported that as she walked by the aggressor's place of business, she exited the shop and yelled at her over past social media posts. The reporting person stated she did not know the woman in real life or online. Responding officers interviewed the aggressor, who agreed to stay away from the person making the original report. A report was generated to document the incident.

07/09/2023 11:40pm A village resident reported an audible alarm from a vacant building on Bedford Road. Responding officers found an open door, and a search of the building revealed graffiti and damage. Officers completed an initial investigation, documented the scene, and were able to re-secure the open door. The incident is currently under investigation.
