

BLOTTER SUMMARY

July 31 through August 6, 2023

The Blotter reports below represent a selection of reports made between the dates above.

07/31/2023 8:53am A resident of Vermilyea Street came to Police HQ to report he lost his wallet. A report was taken, and the man was supplied with the necessary form to have his license replaced at DMV. The man came back a short time later and reported that he had found his wallet, and the DMV form was returned.

07/31/2023 10:27am While on patrol on Broadway, an officer noticed two young people attempting to hide from him in a yard. Further investigation determined that they were AWOL from their residential treatment facility. Both youths were returned back to the care of staff.

07/31/2023 2:36pm A resident of Foxwoods Condominiums requested an ambulance for his wife who was not feeling well. The ambulance and the paramedic were dispatched, and officers attempted to keep the woman comfortable pending their arrival. The patient was transported to the hospital via Pleasantville VAC.

The responding officers provided assistance until EMS arrival. After an initial evaluation by EMS, the mother stated that she was breathing better, and refused any further medical attention.
