

BLOTTER SUMMARY

July 10 through July 16, 2023

The Blotter reports below represent a selection of reports made between the dates above.

07/10/2023 10:05am An officer responded to a report of wires down across the roadway at the intersection of Weskora Avenue and Roselle Avenue. The officer ascertained the wires were telephone lines and was able to secure same to a nearby pole to clear the road. Verizon was notified.

07/10/2023 10:24am A resident of Manville Road reported a blocked driveway on Jackson Alley. The responding officer issued a summons.

07/10/2023 12:59pm An employee of a business on Campus Drive reported a sighting of a mangy coyote. The responding officer canvassed the area, but was unable to locate the animal.

The ambulance and the paramedic were dispatched and responding officers administered first aid pending their arrival. The patient was transported to the hospital via Pleasantville VAC.
