

## **BLOTTER SUMMARY**

**August 28th through September 3rd, 2023**

The Blotter reports below represent a selection of reports made between the dates above.

08/28/2023 9:00am A home health aide in Foxwood Condominiums reported her patient had fallen in the bathroom, but she did not believe the woman was injured. Responding officers requested EMS respond for a medical evaluation, and further interventions were deemed appropriate. The patient was transported to the hospital by Pleasantville VAC.

08/28/2023 12:12pm An officer conducted a traffic stop on Lake Street for an equipment violation. Further investigation revealed multiple violations relating to the vehicle and the driver not having a license. The officer issued multiple summonses, and the vehicle was impounded.

08/28/2023 12:46pm The central monitoring station for an alarm company reported a burglar alarm activation at a residence on Sunnyside Avenue. The responding officers determined that the alarm was set off accidentally by the housekeeper.
