

BLOTTER SUMMARY

August 7 through August 13, 2023

The Blotter reports below represent a selection of reports made between the dates above.

08/07/2023 2:31pm Officers responded to a residence within the village to serve a Temporary Order of Protection (T.O.P.), as well as to remove all firearms as per the directions of the T.O.P. While the officers were on scene, they also facilitated the removal of personal belongings of the protected party of the Order.

08/07/2023 3:01pm An employee of a federal facility in Memorial Plaza reported unknown parties congregating in the rear of location during the overnight hours. The desk officer advised the caller that officers would monitor the area, and advised the caller to contact police if any activity is witnessed by employees.

08/07/2023 11:18pm PO Cole-Hatchard requested EMS for a woman who had approached her and reported she was not feeling well. During their conversation, Officer Cole-Hatchard had determined the woman was intoxicated and unable to get herself home. EMS was dispatched, and the patient was transported to a local hospital by Pleasantville VAC for further medical treatment.

08/08/2023 7:25am The central monitoring station for an alarm company reported a commercial burglar alarm activation at a business on Campus Drive. The responding officers reported that the alarm was accidentally activated by employees on site.

08/08/2023 11:33am Officers responded to a residence within the village to serve a Temporary Order of Protection. The party to be served was not home, but officers spoke with their spouse, who stated they would notify the police when they returned home. The party came to police HQ later in the day to be served with their copy of the T.O.P.

08/08/2023 4:54pm A village resident called to report a suspicious jug/gas can left on the side of the road by Soldiers and Sailors field on Manville Road. The responding officers reported that the suspicious container was a water jug, and removed it.

08/09/2023 1:22pm An anonymous caller reported a gas leaf blower in operation on Clark Street. Responding officers located the crew and advised them of the ordinance, and they complied with the request to cease use.

08/09/2023 7:16pm A 911 call from a cell phone was received, but the caller hung up prior to speaking. Using meta data from the call, the Desk Officer determined the location of the call was in the area of Washington Avenue and Edgewood Avenue. Officers dispatched to the area discovered that a verbal domestic dispute had taken place, and that one of the parties involved had left the scene. A canvass of the area located the party that left on the platform of the Pleasantville train station. Following interviews, officers determined that no crimes had been committed. A NY State Domestic Incident Report was filed.

08/09/2023 8:35pm An employee of a local restaurant called to report a distraught juvenile in their establishment alleging issues at her local residential treatment facility. Officers contacted Mount Pleasant PD, as incident allegedly took place in their jurisdiction.

08/10/2023 12:40pm An employee of a business on Pleasantville Road reported that his spouse, with whom he has marital issues, had showed up unannounced at his place of employment. Responding officers interviewed both parties and the wife left without incident.

08/10/2023 1:33pm Several 911 callers reported a man having a seizure at a theater on Manville Road. The ambulance and the paramedic were dispatched and responding officers administered aid until EMS arrived. The patient was transported to the hospital via Pleasantville VAC.

08/10/2023 2:59pm A resident of Chappaqua requested medical assistance for her sister, who lives in Pleasantville, after she had fallen the day prior and the woman's caregiver expressed concern. Responding officers requested EMS to respond, and they provided assistance until the ambulance and the paramedic arrived. The patient was transported to the hospital by Pleasantville VAC.

08/10/2023 10:09 pm Staff of a residential treatment facility requested police assistance with securing a 13-year-old resident that left campus grounds without permission and was attempting to get on a train. The youth fled from police on the train tracks, and MTA PD was

notified to make the tracks safe. Surrounding agencies were notified, and the AWOL youth was later secured in the jurisdiction of Mount Pleasant PD.

After beeping her horn at a car that she believed was attempting to pull out in front of her, the driver of the vehicle tailgated her for a few blocks, while making rude hand gestures. The ambulance and the paramedic were dispatched, and the responding officers provided an ice pack and stabilized the arm until EMS arrival.
