BLOTTER SUMMARY

August 21 through August 27, 2023

The Blotter reports below represent a selection of reports made between the dates above.

08/21/2023 8:24am The owner of a local landscaping business reported an incident that had occurred the previous Saturday between members of his crew and an unknown person. The man in question had verbally admonished the crew while they were working on a lawn near the intersection of Manville Road and Grandview Avenue. Officers conducted an investigation and identified the man, who lives nearby. When interviewed, he admitted to the incident and reported he was frustrated that the crew was not abiding by the local leaf blower ban. The man was advised should there be any issues in the future, he should contact the police to handle the dispute.

08/21/2023 8:36am A neighbor reported a child screaming from a neighboring residence on Manville Road. Responding officers spoke to the child's grandmother, who reported the child was upset over having to take medication.

08/21/2023 9:09am Following a traffic stop on Marble Avenue, an officer discovered the driver's license was suspended. An investigation was initiated, and the man was determined to be in California. The appropriate agency was notified to follow-up on his wellbeing.

When interviewed, the boy stated he had witnessed an unknown man approach their home. When he saw the young man through the window, he fled. A personal and vehicular description were provided, and the information was forwarded to the Detective Division for further investigation.

08/22/2023 12:06pm A resident of Elmsford reported safety concerns for a crew at a worksite in the village. Responding officers did not observe any safety issues, but the Building Department was notified and responded.

The driver, a 25-year-old resident of the Bronx, was arrested and processed at the scene. He was charged with Aggravated Unlicensed Operation and provided with an appearance date for Village Justice Court. The vehicle involved was impounded.

08/23/2023 8:30pm County Fire Control reported they were dispatching EMS to a facility on Oak Ridge Road for an unresponsive female. Upon arrival, responding officers found the woman to be alert and conscious. Officers assisted the ambulance crew and the paramedic to prepare the patient for transport to the hospital via Pleasantville VAC.

at the same auto body shop as his car. Officers followed up with the owner, who stated his daughter, who was currently away at college, was driving the car and did not realize she had hit another vehicle. She was issued a summons for Leaving the Scene of a Property Damage Auto Accident.

08/25/2023 10:16am The owner of a building under repair on Wheeler Avenue reported an identified truck had hit the scaffolding and left the area. Officers contacted the company who owns the truck and requested the driver return to Police HQ later that day. A summons was issued to the driver for Leaving the Scene of a Property Damage Auto Accident.
