BLOTTER SUMMARY

September 18 through September 24, 2023

The Blotter reports below represent a selection of reports made between the dates above.

09/18/2023 10:20am A resident of Broadway reported that while he was driving near his home, a tree limb had fallen and struck his windshield, causing it to shatter. Upon arrival, responding officers found that the driver of the vehicle was not injured, and that there was no debris in the roadway. The officers assisted the driving in getting his vehicle back to his residence. A report was filed to document the incident.
