## **BLOTTER SUMMARY**

## September 25th through October 1st, 2023

The Blotter reports below represent a selection of reports made between the dates above.

09/25/23 9:43am A local resident came into Police HQ and requested police take custody of a target pistol that was left behind by her late husband, along with other incidental items. Responding officers retrieved the pistol, and determined that some of the ammunition might be unstable, so the Westchester County Police Bomb Squad was contacted for removal. The weapon was secured at the police station where it awaits destruction.

09/25/23 10:15am A resident of Weskora Avenue requested assistance for a family member who lives in Foxwood Condominiums and had suffered an injury to her foot. EMS was dispatched, and the officers maintained pressure to the would while awaiting their arrival. The injured party was then transported to an area hospital for further care.
