

BLOTTER SUMMARY

September 11 through September 17, 2023

The Blotter reports below represent a selection of reports made between the dates above.

09/11/2023 9:06am While on a traffic detail, PO Salameh reported traffic being diverted off the Saw Mill River Parkway due to an unapproved tractor trailer blocking traffic. The officer remained in the area to assist with traffic control.

09/11/2023 9:16am County Fire Control reported an activated fire alarm at a residence on Mountain Road. Responding officers and fire department personnel could not determine a source of the alarm, and Pleasantville FD cleared the scene. Con Edison was requested to respond to follow up with the homeowner.

09/11/2023 4:08pm A Weskora Avenue resident requested assistance with getting his wife up after a fall in their home. After assessing the woman and determining she was not injured, responding officers were able to help her back to her feet.

09/11/2023 4:25pm A local resident reported concern for an elderly gentleman walking eastbound on the shoulder of Bedford Road near traffic. Officers checked the area but were unable to locate the man.

09/12/2023 12:35am Officers conducted a walk thru of an unoccupied building on Washington Avenue after seeing what appeared to be a flashlight in use inside. Officers located two men, who they confirmed were security guards that had been hired by the building owner.

09/12/2023 3:25 pm A village crossing guard reported an unattended package in the area of the Bedford Road School. The responding officer determined the package was a tent, and located the owner of the property, who came to Police HQ to retrieve it.

09/13/2023 7:43 am A resident of Bedford Road reported construction work being performed at a residence near his home in violation of the village noise ordinance. The

responding officer discovered that although workers were on scene doing prep work, no gas-powered equipment or similar were in use.

09/13/2023 10:44am A resident of the Country Club reported vehicles parked obstructing the sight lines at the intersection of Broadway and Country Club Lane. The vehicles were gone upon the arrival of the responding officer.

09/13/2023 2:02 pm A caller reported a vehicle stopped in the roadway, with the driver slumped over the wheel, at the intersection of Marble Avenue and Castleton Street. Responding officers determined that the driver was not in need of medical attention, but the vehicle was disabled. A local towing company was contacted and assisted with the removal of the disabled vehicle.

09/13/2023 3:38pm A three-car property damage auto accident was reported on the Saw Mill River Parkway near the intersection with Grant Street. Westchester County Police were notified. Responding officers were assisting the drivers and passengers involved when it was determined that one of the cars was on fire. Pleasantville Fire Department and EMS were dispatched, and the fire was extinguished by officers on the scene. The scene was eventually turned over to the Westchester County Police.

09/13/2023 9:45pm A Village resident reported a person he did not recognize lingering in his neighborhood. A personal description was provided, as well as a description of a possible vehicle involved. A short time later, an officer observed the described vehicle on Marble Avenue; however, the operator did not match the description of the suspicious person. A further canvass was negative.

09/14/2023 12:02 pm County Fire Control reported they were dispatching EMS to a residence on Vanderbilt Avenue for an unconscious party. Upon arrival, responding officers found the woman had regained consciousness but was still weak. She was kept comfortable pending EMS arrival. The patient was transported to the hospital via Pleasantville VAC.

09/14/2023 3:43pm A resident of Maple Hill Road reported wires that had become loose after being struck by a passing truck. Responding officers determined that both cable and electrical wires were affected, but no hazard to vehicles or pedestrians was present. Con Edison and Verizon were notified.

09/14/2023 6:53pm A neighbor reported a noise complaint from a barking dog at a residence on Meadow Lane. Responding officers noted that the barking had stopped, but made contact with the dog's owner, who advised they would address the problem in the future.

09/14/2023 7:07pm A noise complaint was received regarding construction in progress at a residential location on Manville Road. Responding officers found the area quiet, but located the source of the previous noise. They clarified the terms of the ordinance with the foreman on scene.

09/14/2023 9:16pm A resident of Grove Street reported illegal parking on Cooley Street. The responding officer mitigated the situation and all vehicles involved were relocated.

09/15/2023 1:38am A resident of Foxwood Condominiums reported disturbing text messages from a friend threatening self-harm. Officers interviewed the text-sender at his residence in the Village, and he admitted to some of the statements. An ambulance was dispatched, and the man was transported to the hospital for a mental health evaluation.

09/15/2023 1:52am Mount Pleasant PD reported they had been contacted by the staff at a residential treatment facility reporting three AWOL residents, who may be in the Village. Officers canvassed multiple locations throughout the Village based on observations by civilians, until all students were returned to campus.

09/15/2023 7:22am Multiple callers reported a tree branch blocking the northbound lane on Marble Avenue in front of All Souls Cemetery. The responding officer found that a DPW crew was already on the scene to remove the branch from the lane of traffic.

09/15/2023 8:43am A resident reported they were bitten by a dog while walking on Manville Road. The responding officer investigating the incident requested EMS to the scene. The patient was transported to the hospital via Pleasantville VAC.

09/15/2023 12:17pm A resident of Hopper Street came to Police HQ to report that he had observed two youths acting suspiciously near his home via his security camera. The responding officers canvassed the surrounding area for the youths, as well as any damage or suspicious items, with negative findings. A report was filed for Detective Division follow-up.

09/15/2023 3:45pm A resident of Sunnyside Avenue reported a neighbor using a gas-powered leaf-blower in violation of the Village ordinance. Responding officers advised the violator that the ordinance was in effect through the end of the month, and he ceased operation.

09/15/2023 9:41pm A passerby noticed a group of youths walk into a local business establishment after hours while the business was clearly closed. Responding officers determined that the clerk, who was cleaning up after hours, had let the youths in to use the bathroom. Officers made notification to the youth's parents, as some behavior inside and around the store was concerning. In addition, they spoke with the clerk, advising her to cease letting anyone in after hours.

09/15/2023 9:53pm A resident of Hillview Terrace reported she was with her neighbor who is suffering from an irregular heartbeat and high blood pressure. The ambulance and the paramedic were dispatched, and responding officers assisted in preparing the woman for transport. The patient was transported to the hospital via Pleasantville VAC.

09/16/2023 5:00am Despite posted warnings, two vehicles were impounded for the Memorial Plaza Lot for violation of the parking restrictions for the Farmer's Market.

09/16/2023 11:15am A local business owner on Marble Avenue reported he received a notification of an activation of his security camera and noticed a young woman crying and pacing at the location. Responding officers located the woman, who is known to this Department, and attempted to calm her down. Her parents were contacted and the family was reunited.

09/16/2023 5:23pm An employee of a coffee shop in Memorial Plaza reported youths had just left the store after throwing food and causing a disturbance. The group was last seen on bicycles toward Bedford Road. Responding officers canvassed the area and located the group a few blocks away. One member of the group took responsibility for the disturbance, and the store manager requested they be advised of the inappropriateness of their actions.

09/17/2023 1:01pm A resident on Bedford Road called to report a cracked/broken back window in their vehicle that had occurred while the vehicle was parked and unattended.

Officers responded and took a report but were unable to determine if any crime had been committed. The case remains under investigation.

09/17/2023 10:32pm A person who lives nearby reported loud music coming from a vehicle on Hobby Street. Responding officers located the source of the noise: a man waiting for his cousin to come home. The driver complied with the officer's request to turn the music down.
