The Blotter reports below represent a selection of reports made between the dates above.

10/09/2023 5:49am County Fire Control reported they were dispatching Pleasantville FD to an automatic fire alarm at a residence on Brentwood Drive. The responding officers assisted FD personnel to determine the alarm was set off in response to a water leak, and the scene was cleared by Pleasantville FD.
