

## **BLOTTER SUMMARY**

**February 20 through February 26, 2023**

The Blotter reports below represent a selection of reports made between the dates above.

02/20/2023 7:43am The owner of a local business reported an illegally parked vehicle blocking the entrance to his garage. The responding officer ran the vehicle's information, and the owner was contacted to move the car.

02/20/2023 8:20am A resident of the Clinton Street Center requested assistance getting up after a fall. Responding officers determined that the woman was not injured, so they assisted in getting her upright without the need for an EMS response.

02/20/2023 4:28pm A Saratoga Avenue resident reported a group of youths in the roadway, using a tripod to shoot projectiles, possibly striking vehicles. Officers responded and canvassed the area, but did not locate the youths or damage to any vehicles.

02/20/2023 8:36pm The central monitoring station for a health care service reported a resident at the Clinton Street Center fell after feeling of dizziness. Responding officers and EMS personnel assessed the patient, who refused further medical attention.

02/20/2023 9:01pm A member of the Pleasantville Fire Department reported wires hanging from a pole in front of the Washington Avenue firehouse which would delay the response of an emergency vehicle. The cable company was notified to address the problem.

02/20/2023 9:16pm A Village resident reported a group of youths atop the Sunnyside Avenue underpass who threw an item and struck his vehicle. No damage to the vehicle was reported. MTA PD was notified, and Mount Pleasant PD units assisted Pleasantville officers canvass the area. The boys, who were from nearby towns, were located at various locations near Marble Avenue and transported to Police HQ to be turned over to their parents.

02/21/2023 5:57pm A resident of the Clinton Street Center reported they were locked out of their apartment. An officer responded and was able to gain entry.

02/21/2023 5:58pm A 911 caller reported an erratic driver traveling southbound on Bedford Road from Chappaqua. Responding officers were able to locate the vehicle and initiated a traffic stop at Garrigan Avenue and Broadway. After speaking with the driver, officers determined the deteriorating weather conditions caused the perceived erratic operation, and the driver was sent on their way.

02/22/2023 12:16am A resident of Greenmeadow Road reported that she had been awakened by a person banging on her front door. Reporting officers did not observe anyone in the area on their approach, and canvassed the area with negative results. Information was turned over to detectives for further investigation.

02/22/2023 1:11pm A resident of Foxwood Condominiums reported that her neighbor was engaging in behavior to harass and annoy her. An officer responded and took a report for documentation purposes, but the narrative of events detailed that no crimes were committed.

02/22/2023 6:03pm A resident of Stanley Street requested assistance for his mother, who had fallen in the home. The woman was assisted up from the floor by responding officers. The paramedic was dispatched for an assessment, and although she was complaining of pain in her shoulder, the woman refused further medical interventions.

02/22/2023 9:41pm A Village resident called from Manville Road requested assistance to get home. Upon arrival, officers determined the woman was intoxicated and provided transport to the home for her safety. A short time later, her mother called and requested further interventions due to her altered mental state. The ambulance and the medic were dispatched, and the patient was transported by a mutual aid ambulance to the hospital for further evaluation. The Mobile Crisis Team was advised of the situation and will offer services to the family.

02/23/2023 4:02pm A local resident reported a two-car motor vehicle accident at the intersection of Marble Avenue and Hobby Street with no reported injuries. Officers responded and determined that a vehicle exiting Hobby Street to enter Marble Avenue northbound failed to yield the right of way to a vehicle traveling southbound on Marble Avenue. A NY State Accident Report was filed.

02/23/2023 7:30pm A resident of Hawthorne reported a dog locked in a vehicle in the parking lot behind retail establishments in the Old Village. The caller was concerned because of the cold temperature outside. Officers located the vehicle's owner and checked on the welfare of the dog, who appeared to be no worse for the experience.

02/24/2023 10:49am A resident of Seneca Lane reported a falling tree had taken down some power lines on her property. Officers responded and determined power was not lost to the surrounding area. Con Edison was dispatched to respond and officers endeavored to make the area safe pending their arrival.

02/24/2023 1:33pm A Village resident reported that her adult son had been bitten by an unknown dog while walking in the area of Saratoga Avenue and Garrigan Avenue. The dog was leashed and being walked by its owner, who did not engage with the victim despite the obvious interaction with her dog. Officers canvassed the area for the dog, described as a reddish or tan husky, but were unable to locate it. A dog bite form was filed with the Department of Health. A few days later, the caller reported that the bite had become infected. Following an investigation and with the assistance of the victim, the owner of the dog was identified two weeks after the initial bite. The owner provided proof of vaccinations to the responding officer.

02/24/2023 4:24pm Mount Pleasant PD requested assistance in the search for a vehicle which just fled from a motor vehicle accident into Pleasantville on Garrigan Avenue. The vehicle was described as a gray or silver Volkswagen Passat. Officers canvassed the area with negative results.

02/24/2023 7:17pm Westchester County PD requested assistance at the intersection of Grant Street and the Saw Mill River Parkway for report of a pedestrian struck by a motor vehicle. Responding officers maintained the scene and provided medical assistance to the victim until WCPD officers arrived to complete the investigation and file all necessary reports.

02/25/2023 12:10am A Village resident reported what sounded like a party with screaming and loud music at a residence on Hillview Drive. Officers canvassed the area and found the area quiet. Attempts to speak to anyone at the reported location were unsuccessful.

02/25/2023 4:01am The clerk at a convenience store on Bedford Road reported the larceny of two lottery tickets. Responding officers canvassed the area for the subject, who was known to the clerk and the officers, but he was not located. Later that day, the owner called back and reported the theft was actually far larger than originally reported. The investigation is continuing.

02/25/2023 10:10am The central monitoring station for an alarm company reported a residential alarm at a residence on Country Club Lane. Officers responded and discovered the alarm was set off in error by a home health aide.

02/25/2023 12:55pm Mount Pleasant PD reported a minor accident at the intersection of Marble Avenue and Stanley Street. One vehicle attempted to make a left turn from Marble Avenue in front of the other vehicle, and the two collided. No injuries were reported, but responding officers requested a tow truck for one of the vehicles involved. A NY State Accident Report was filed.

02/25/2023 10:12pm A resident of Marble Avenue reported that an unknown party had kicked the front door to his building. The suspect was described as possibly in his teens, with specific clothing and traveling with a group of three (3) other people. He left the scene southbound on Marble Avenue. Officers found no damage to the door, but canvassed the area for the suspects with negative results.

02/25/2023 11:00pm Mount Pleasant PD requested assistance in locating a suspect involved in a domestic assault incident in their jurisdiction. Responding officers and detectives located the suspect on Madison Avenue and maintained control of the driver until Mount Pleasant PD units could place him under arrest.

02/26/2023 8:51am An anonymous passerby turned in a locked iPhone that was found at the bus stop on Bedford Road near Wheeler Avenue. Investigation by the Desk Officer led to the discovery of the phone's owner. The owner was contacted and an officer returned the phone to her.

02/26/2023 5:00pm A resident of Cedar Avenue turned in a wallet that he had found while walking near his home. The owner of the wallet was located and was reunited with her lost property.
