The Blotter reports below represent a selection of reports made between the dates above.

02/27/2023 9:27am A resident of the Pleasantville Senior Center reported she had locked herself out of her apartment. The responding officer discovered that the caller had found her keys upon arrival and was able to gain entry into her residence.
