BLOTTER SUMMARY

3/14/2022 through 3/20/2022

The Blotters listed below represent a selection of reports made between the dates above.

03/14/2022 9:34am A caller from Romer Avenue reported a low hanging wire across the roadway. Shortly thereafter, a second caller reported the wire is a telephone service line to her home. The responding officer was able to secure the loose wire to a utility pole, and Verizon was notified for a service response.

03/14/2022 11:29am A resident of Booth Street called to report that she had locked herself out of her vehicle parked in the Key Foods parking Lot on Pleasantville Road. Officer Burns was able to assist her to gain access.

03/14/2022 6:23pm Officers responded to a residence on Manville Road when a home health care aide reported an aided case involving an elderly female with an unknown medical condition. Officers treated the woman pending the arrival of EMTs and the paramedic. The patient was transported to the hospital via Pleasantville VAC.

03/15/2022 12:25am This Department received a 911 call from a resident of Manville Road reporting that his girlfriend would not leave his residence when he asked her to do so. Upon further investigation, responding officers determined that multiple Domestic Violence offenses had been committed by the caller prior to their arrival. The man was arrested and charged with felony and misdemeanor charges. He was arraigned in the Pleasantville Justice Court and released on his own recognizance pending a future court appearance.

03/15/2022 9:11am The operator of a commercial bus being operated on Bedford Road reported that he had just been involved in a property damage auto accident. He stated that while driving northbound near Oak Hill Circle, his bus was sideswiped by a vehicle proceeding southbound, which did not stop following the accident as required. A canvass of the area was negative. A NY State Accident Report was filed.

03/15/2022 2:12pm A caller reported a man had just walked into traffic on Manville Road in a rage, and it appeared that he was trying to be struck by a vehicle. Responding officers

located the man, who is known to this Department, in a coffee shop on Washington Avenue. During the officer's interview with the man, he abruptly left the store and again darted into traffic in the officer's presence. The man was deemed a threat to himself and was transported by Pleasantville VAC to the hospital for a physical and mental health evaluation. A social worker who is familiar with the man and his case was notified for outreach.

03/15/2022 6:36pm Mount Pleasant Police requested assistance in locating a female who was involved in a family dispute in their jurisdiction and was reported to be walking northbound on Marble Avenue from Thornwood. The young woman was located near the intersection with Hopper Street. Mount Pleasant officers responded to the location to complete their investigation.

03/15/2022 6:56pm Officers responded to a multi-family residence on Saratoga Avenue after one of the tenants complained that their power was out. Officers investigated and located breakers off in the electrical panel. The power was restored.

03/16/2022 3:11am The central monitoring system for the Bedford Road School reported both fire and burglar alarm activations at the school. Pleasantville FD was dispatched via County Fire Control. Responding officers and FD personnel deemed the alarms were caused by a malfunction.

03/16/2022 11:07am The principal of Pleasantville High School reported a hit and run involving a student and a vehicle at the intersection of Sunnyside Avenue and Clinton Street at approximately 7:45am. While exiting his vehicle parked on the southbound side of Sunnyside Avenue, a truck being operated southbound struck him with its passenger-side mirror. The student suffered a minor injury from the impact, and the vehicle left the scene. It is very likely the driver did not realize he had struck the student. The vehicle involved was described reported to be a white pickup truck with a metal box in the bed. The student was treated at the school for his injuries but refused further medical attention. The investigation is continuing.

03/16/2022 1:40pm The owner of a business on Bedford Road came to Police HQ to report he had been the victim of identity theft. He had recently become aware that multiple banking accounts were being opened in the name if his business without his knowledge. At the present time, no funds had been lost by the victim, but bank records involved were secured for a follow-up investigation.

03/16/2022 4:38pm A caller reported a man in Memorial Plaza waving his arms and talking to himself. Responding officers located the man and interviewed him; however, he did not wish to identify himself and was not deemed to be a threat to himself or anyone else. He left the area without incident.

03/16/2022 6:07pm A local building owner came to Police HQ to report that earlier in the day, his building was struck by a vehicle owned by a neighboring business. Both the building and the vehicle involved sustained damage. The driver was located and multiple traffic tickets were issued. A NY State Accident Report was filed.
