

BLOTTER SUMMARY

January 1 through January 7, 2024

The Blotter reports below represent a selection of reports made between the dates above.

01/01/2024 11:54 am A customer reported a woman passed out at a business in Memorial Plaza. EMS was dispatched, and upon arrival, the responding officers found the woman to have regained consciousness. She was provided oxygen while awaiting the arrival of the ambulance and the paramedic, and was eventually transported to the hospital by Pleasantville Ambulance.

01/02/2024 2:17am A passerby reported the driver of a vehicle parked in the roadway of Memorial Plaza either sleeping or passed out. Responding officers located the vehicle and during the interview process, the driver, a 36-year-old man from Mohegan Lake, was determined to be intoxicated. He was arrested, transported to Police HQ and processed on a charge of Driving While Intoxicated. He was arraigned before the Village Justice and released on his own recognizance with a court date in the future.

01/02/2024 2:38pm A resident of Country Club Lane reported a van following a student from a local residential treatment facility in the area near her home. The responding officer canvassed the area but the student and the van were gone upon his arrival.

01/02/2024 6:52pm A village resident came into Police HQ to report a past domestic incident that occurred at their home. The responding officers took a preliminary report, and a New York State Domestic Incident Report was filed. The investigation is ongoing.

01/02/2024 10:40pm The central monitoring station for an alarm company reported a burglar alarm activation at a restaurant on Marble Avenue. The responding officers checked the exterior, and found the building to be secure.

He was transported home and left in the care of their spouse. Options for securing the home and maintaining the party's whereabouts were discussed with the family.

01/03/2024 6:18pm A Medical Alert operator requested assistance for a woman who had fallen in her home and was possibly injured. The responding officers located the woman on the floor, awake and alert. She reported she had been on the floor for approximately one hour prior to activating the medical alert necklace. EMS was dispatched, and the officers provided assistance to the woman until they arrived. The patient was transported to the hospital by Pleasantville VAC.

01/04/2024 12:00am County Fire Control reported they were dispatching EMS on a request from MTA Police who were assisting a woman at the Pleasantville Train Station. Responding officers assisted MTA PD while awaiting the arrival of the ambulance and the paramedic. The woman eventually refused further medical attention.

01/04/2024 11:16am While on foot patrol, an officer reported a vehicle had just struck a building on Wheeler Avenue. No one was injured, and the Building Inspector was requested to respond to ensure the structural integrity of the building. A NY State Accident Report was filed, and the vehicle was towed away from the scene.

The responding officer learned that one truck had broken down, and the other was attempting to assist.
