## **BLOTTER SUMMARY**

## January 16 through Jan 22, 2023

The Blotter reports below represent a selection of reports made between the dates above.

01/16/2023 4:07pm A caller from North Place reported a group of youths in the woods near Tompkins Avenue. Responding officers located the group, who were just enjoying the day off from school, and sent them on their way.
