## **BLOTTER SUMMARY**

## January 23 through January 29, 2023

The Blotter reports below represent a selection of reports made between the dates above.

01/23/2023 6:25am A resident of Dogwood Lane reported a power outage in the area. The responding officer confirmed the condition but could not locate an apparent cause. Con Ed's Electric Division was notified.

01/23/2023 9:01am The crossing guard at Bedford Road and Academy Street reported traffic concerns around a Con Edison construction detail on Bedford Road. Bee-line buses were being diverted and were creating a traffic condition. The responding officer and Sergeant worked with the project foreman to devise a solution that provided for a safe environment for the work to continue, while addressing traffic concerns. The work will continue for approximately one to two weeks, and Bee-line buses have been re-routed for the hours of construction, so that the bus pick-up and schedule will not be affected.
