

## **BLOTTER SUMMARY**

**January 30 through February 5, 2023**

The Blotter reports below represent a selection of reports made between the dates above.

01/30/2023 11:16am A resident of the Sherman Park area reported that her mother had suffered injuries from a fall in their home. Responding officers assessed her level of injury and kept her comfortable awaiting the arrival of EMS personnel. The patient was transported to the hospital via a mutual aid ambulance.

01/30/2023 3:51pm A resident of Greenmeadow Road reported that she had discovered a locked interior door, and was concerned someone was else inside her home. Responding officers gained access to the locked room and cleared the rest of the home to find no one else in the residence.

01/30/2023 5:10pm One of the drivers involved reported a property damage auto accident at the intersection of Manville Road and Pleasantville Road, in which one of the vehicles involved fled the scene. As a precaution, responding officers requested EMS for a baby passenger in the vehicle that remained, but he was uninjured. A vehicle and driver description of the second vehicle, which was last seen turning onto Grant Street toward the Saw Mill River Parkway, was gathered, and a license plate was obtained by video. The area was canvassed with negative results, but the case was turned over to the Detective Division for follow-up. A NY State Accident Report was filed.

01/30/2023 6:15pm A 911 call was received from a residence on Greenmeadow Road, and no answer was received on the attempts to call back. Responding officers determined that the call was placed in error by the homeowner.

01/31/2023 10:43am County Fire Control requested EMS personnel and a police response to a residence on Pierce Drive for an elderly male with chest pain. Upon arrival, officers inquired as to medical conditions and past history. Upon the arrival of EMS personnel, officers assisted with removing the patient, who was transported to a local hospital for further evaluation via Pleasantville VAC.

01/31/2023 1:56pm A resident of Ashland Avenue reported a large truck idling for an extended period of time on the street near her home. Responding officers determined the truck had just finished a delivery of materials to a home under construction and was in the process of leaving.

01/31/2023 A resident of Hill View Drive reported a car blocking the view of the stop sign at the intersection of Hill View Drive and Washington Avenue, causing an unsafe condition. The responding officer determined the car was within 15 feet of the sign in violation of NY State Vehicle and Traffic Law, and issued a summons.

01/31/2023 06:58pm Officers responded to the area of Bedford Road and Cooley Street on the report of a fight in progress. The victim was located, but the suspect had fled the scene. The victim reported that as he was walking westbound on Bedford Road, he had a brief exchange of words with a man unknown to him, at which time the suspect followed him and began to shove him and hit him from behind. The suspect then fled the area toward Memorial Plaza. A canvass for the suspect, described as a white male, approximately 5'5" with a thin build, short dark hair and brown eyes, wearing a brown plaid jacket and dark pants, was unsuccessful. The victim refused medical treatment, but completed a supporting deposition. The investigation is continuing.

01/31/2022 9:332pm County Fire Control requested police and EMS to a residence in the Village for an opioid overdose. The ambulance and the paramedic were dispatched, and upon their arrival, officers found the victim unconscious but breathing. A dose of Narcan was administered, and when no improvement was detected, a second dose was administered, and the victim's pulse strengthened. The patient was transported to the hospital via Pleasantville VAC.

02/01/2023 3:00pm The crossing guard at Pleasantville Road and Manville Road reported an elderly woman needing assistance, as she appeared to be a confused. Responding officers located the woman on Bedford Road near Cooley Street, and determined she was in good health but a long, uphill walk away from her residence. She was provided a courtesy transport.

02/01/2023 5:18pm A passerby reported a motor vehicle accident at the intersection of Manville Road and Pleasantville Road. Two vehicles collided when one car attempted to make a left turn from Manville Road onto Pleasantville Road in front of the other. No injuries were reported, but an airbag in one vehicle was deployed, so it was towed from the scene. A NY State Accident report was filed.

02/01/2023 7:37pm A resident of Mount Kisco came to Police HQ to report that her wallet had been stolen from outside a business on Washington Ave. The victim reported she had put her wallet down for a short time and when she returned, the wallet was gone. Video surveillance of the area showed a man picking up the wallet and leaving the area. Officers extensively canvassed the area for the individual in the video, but he was not found. The video and case were turned over to the detective division for further investigation. On February 3, it was determined that the man had, in fact, anonymously dropped the wallet off at another business in the area immediately after the incident, and the owner was reunited with the wallet with all contents intact.

02/02/2023 12:57am A Lenox Avenue resident called 911 to request EMS for her husband who was not feeling well. Pleasantville Ambulance and a paramedic were dispatched, and officers monitored the man's condition while awaiting their arrival. The patient was subsequently transported to a local hospital for further medical treatment via Pleasantville VAC.

02/02/2023 6:23am A passing motorist reported a disabled vehicle near the intersection of Manville Road and Parkway Terrace. Responding officers located the vehicle on the exit ramp from the Saw Mill parkway southbound, and with the assistance of another motorist, pushed it off the ramp to a safe area. A tow truck had already been contacted, so officers left a flare for safety and cleared the scene.

02/02/2023 11:39am A resident of the Clinton Street Center reported hearing cries for help from a neighboring apartment. Officers responded and discovered a resident who had fallen and could not get up. Officers requested the ambulance to the scene to perform an evaluation and assist with getting the party on her feet. No injuries were found, and she refused further medical attention.

02/02/2023 5:13pm A village resident reported she was a victim of an internet scam. After being alerted on her computer that a subscription for anti-virus protection was about to expire, she called the number on the company website. The technician she reached walked her through the process, but was able to convince her to submit a payment in excess of the scheduled amount. An officer took a report, and the matter is currently under investigation by the Detective Division.

02/03/2023 1:15am A caller from a local nightlife establishment on Cooley Street requested emergency medical services for a customer with injuries from a fall. Responding officers found the woman, a resident of Pleasantville, unconscious, but she was easily roused. The ambulance and paramedic responded and the injured party was transported to a local hospital by Pleasantville VAC.

02/03/2023 2:12pm The central monitoring station for an alarm company reported a residential alarm activation at a home on Manville Road. Officers checked the exterior of the home and found it secure on the ground level.

02/03/2023 8:37pm A resident of Broadway called 911 to report his preschool-age son was having a seizure and not breathing. The Desk officer dispatched responders and advised the father how to administer rescue breaths. Upon their arrival, officers found the boy breathing and recovering from the episode. Officers assisted the EMS personnel, and the patient was transported to a local hospital by Pleasantville VAC.

02/04/2023 12:06am An alarm company called to report a motion alarm at a residence on Club Court where the resident was home and unsure of any intruders. Upon their arrival, responding officers found the alarm was malfunctioning. The homeowner stated he would follow up with his alarm company.

02/04/2023 3:33pm A resident of Bedford Road reported that she lent her vehicle to an acquaintance over two weeks ago, and the vehicle has not been returned. Officers responded and took a report. The matter is currently under investigation.

02/04/2023 6:25pm A local resident reported cars parked in violation on Irvington Street. The vehicles were being moved upon the officer's arrival.

02/05/2023 10:50am An employee from a local delicatessen reported that a woman had fainted in the business. EMS personnel were dispatched, and responding officers assisted the woman, who had regained consciousness. She eventually refused further medical attention.
