

## **BLOTTER SUMMARY**

**5/23/2022 through 5/29/2022**

The Blotter reports below represent a selection of reports made between the dates above.

05/23/2022 12:34am A caller who was not at the location reported a domestic disturbance in progress at a home on Washington Avenue. Upon arrival, officers interviewed the homeowner, who reported an argument with her boyfriend that had escalated. Damaged property was observed throughout the apartment. The boyfriend was placed under arrest and charged with Criminal Mischief. He was arraigned by the Village Justice, and he was released on his own recognizance and ordered to return the next evening court is in session.

05/24/2022 12:22am A caller from Manville Road reports two people actively engaged in a loud conversation that might be arguing. Patrol arrived on scene and canvassed the area but were unable to locate anyone.

05/24/2022 12:03pm A caller from Bedford Road reports that her grandmother has fallen and struck her head, which is now bleeding. Pleasantville VAC and Medic were paged for response, and responding officers administered first aid awaiting their arrival. The patient was transported to the hospital via Pleasantville VAC for further treatment.

05/24/2022 10:20pm A resident of Pleasant Avenue requested assistance in retrieving his car keys, which were locked in his vehicle while it was parked in his driveway. The responding officer was able to gain entry to the vehicle without further incident.

05/25/2022 02:28am Officers responded to a life alert activation at a residence on Foxwood Drive. Upon their arrival, they were met by the homeowner who reported multiple stresses in her life, including a disturbing premonition she had. The officers made contact with the woman's daughter, who responded to the residence to calm and comfort her.

05/25/2022 3:46pm A passing motorist called to report a man yelling at passing kids and throwing rocks at cars on Manville Road near Pleasantville Road. A description was given, and officers located the man on Sarles Lane. After a brief interview, the man was deemed to be

a danger to others. He was transported to the hospital for a psychological evaluation by Pleasantville VAC with an officer on board the ambulance for security.

05/26/2022 1:48am A resident of the Clinton Street Center reported that she had fallen and needed help getting back up. Upon arrival, officers immediately requested an EMS response, as they recognized the need for further medical attention for injuries from a fall. The woman was transported to the hospital by Pleasantville VAC for further treatment.

05/26/2022 10:59AM Officers responded to a local preschool at the request of staff members for a child who had fallen and was lethargic. Officers assisted in providing care to the child who had no visible signs of trauma. She was transported with her mother by Pleasantville VAC to the hospital for further evaluation.

05/26/2022 8:04pm A Manville Road resident reported a possible disturbance on Weskora Avenue. The caller stated he heard an agitated male screaming in the distance. Officers arrived on scene and conducted a neighborhood canvass which included knocking on residence doors and interviewing possible witnesses. Officers made contact with a resident of Weskora Avenue, who stated he was having a heated conversation on the phone in regard to a previous, unrelated incident. Officers deescalated the man and asked him to be mindful of his neighbors when on the phone.

05/26/2022 8:10pm A resident who lives in the neighborhood reported parking violations in the area of a restaurant on Marble Avenue. The responding officer issued four parking summonses to vehicles in violation.

05/26/2022 10:44am A resident of Foxwood Condominiums came to Police HQ to report a possible violation of a Temporary Order of Protection. After investigation, it was determined that the protected person's personal information had inadvertently been shared with the respondent of the TOP. The incident was never threatening or intimidating, but both parties were advised on how to secure information and how to avoid violating the specific terms of the TOP.

05/27/2022 11:19am A local resident came to Police HQ to report multiple instances of identity theft against him and his wife. For the past few months, he has been receiving notices

of credit accounts being opened in his name. Although no financial loss has yet occurred, the man wished to document the issue, and he was advised on how to secure his credit.

05/27/2022 11:40am Officers responded to a commercial building on Bedford Road for a report of a trespassing incident in the past. Upon arrival, officers were escorted to a vacant office space where an adjacent renter had noticed an unsecured door, and upon entering, discovered evidence of someone staying there. The investigation revealed someone had unlawfully entered and remained on the property at some point in the prior five days. Members of the Detective division processed the scene, and the building owner was notified.

05/27/2022 2:24pm A man from Washington Avenue requested an ambulance for his elderly relative who had suffered minor injuries from a fall. Officers attempted to staunch some minor bleeding while awaiting the arrival of the ambulance. The patient was transported to the hospital via Pleasantville VAC.

05/27/2022 3:10pm Upon a report of a tractor trailer being operated on the Saw Mill River Parkway, officers responded to assist with traffic control. Officers assisted the Westchester County Department of Public Safety officers with clearing the unauthorized truck from the Parkway.

05/27/2022 9:22pm After receiving a call from a resident of Hillview Drive reporting multiple "ring and run" incidents, Sergeant Zane located the group responsible and advised them to cease harassing the neighbors.

05/28/2022 1:51am This Department received a 911 call reporting a structure fire on Sunnyside Avenue. Patrol units and Pleasantville Fire Department responded and reported that the fire was in the rear and attic portion of the home, and all residents were confirmed evacuated. Additional resources were requested, including Thornwood, Chappaqua and Briarcliff FD's and the Pleasantville VAC Rehab Unit. Neighboring homes were evacuated as a precautionary measure. Once extinguished, it was determined that the home was not habitable until further inspection by Village Building Inspector. The homeowners were provided with a place to stay with neighbors.

05/28/2022 2:02pm A resident of Willis Place reported a possible blocked sewer drain due to the heavy flow of water on his street. Responding officers determined that the water was the result of storm water runoff only.

05/28/2022 2:05pm A staff member at adult group home on Oak Ridge Road requested assistance for a patient who had fallen but had not suffered an injury. Upon arrival, the responding officer requested a paramedic come to the scene, who assisted in deciding that the patient be transported via Pleasantville VAC to the hospital for a more thorough evaluation.

05/28/2022 6:17pm A woman from Thornwood reported that a woman she does not know had approached her on Wheeler Avenue and made threats to her and intimidated her. Responding officers spoke to the complainant, who stated that she did not wish to pursue the matter but just wanted to it documented. Officers also spoke to the female aggressor and warned her about her conduct. Both parties went on their way without incident.

05/28/2022 9:07pm A 911 hang-up call was received. Responding officers spoke to the homeowners of the location from where the call had come, and determined that the children in the home dialed the call in error.

05/28/2022 11:36pm The owner of the 7-11 store called to report a female lying outside his store. Responding officers and found an intoxicated juvenile from out of town on the ground. A medical evaluation determined it was safe for the female to be sent home with her parents, who were contacted and took custody of her.

05/29/2022 7:18am A resident of San Antonio, Texas called to request a welfare check on her parents, who live in the country club and from whom she has not had contact in an unusual amount of time. Responding officers made contact with the caller's mother, who assured them everything was in order, but asked for assistance for her husband, who was having difficulty after getting out of bed. The assistance was provided and the mother contacted her daughter to let her know everything was OK.

05/29/2022 8:21am A resident of an apartment on Manville Road called to request assistance with her carbon monoxide detector, which had been beeping periodically for some

time but had now stopped. Sergeant Gilmartin assisted the woman in replacing the battery for the unit.

05/29/2022 9:37am A woman who lives in the Village reporting a domestic incident from the previous night involving her estranged husband. The woman stated that in the early morning hours, her husband, who had previously moved out, had entered the residence she shares with their children through a window. Once inside, he attempted to assault her and destroyed property. Officers searched multiple locations for perpetrator, and eventually located him by phone and convinced him to surrender himself. The man was charged with multiple felonies, including Attempted Rape in the First degree, Burglary in the Second Degree, and Criminal Mischief in the Fourth Degree. The man was released on \$500 bail, and orders of protection were issued for the victim and her two children.

05/29/2022 11:16am A minor auto accident was reported on Wheeler Avenue. The driver of a car backing out of a parking space did not notice the car stopped in traffic behind her, and the two vehicles made contact. No injuries were reported, and a NY State Accident Report was filed.

05/29/2022 1:48pm A resident of Southeast Pleasantville called to report a power washer being used in violation of the noise ordinance. Responding officers advised the homeowner of the ordinance, who stopped using the machinery as required.

05/29/2022 6:50pm The central monitoring station for a gas station on Bedford Road reported an alarm activation. Officers checked the premise and reported the business to be secure. Approximately an hour later, the alarm company called back with another alarm, and the premise was found to be secure again. On the third false activation a short time later, the owner was contacted.

05/29/2022 6:58pm Officers assisted the New York State Police, who were pursuing a stolen car southbound on the Saw Mill River Parkway. Officers were able to stop following the stolen car when the pursuit was taken over by aviation units.

05/29/2022 11:22pm A resident of Manville Road called to request assistance in getting back up after a fall. Responding officers helped the man back to his feet.
