

BLOTTER SUMMARY

October 16th through October 22nd, 2023

The Blotter reports below represent a selection of reports made between the dates above.

10/16/2023 3:23am The central monitoring station for an alarm company reported an activated alarm at a business on Broadway. Responding officers found the building secure and all appeared in order.

10/16/2023 8:38am The owner of a business on Wheeler Avenue reported he had observed a man sleeping in his store via his security camera. Upon arrival, officers found that the man had already left, but located him a short distance away. The man was offered services, which he declined, and he was sent on his way.

10/16/2023 1:51pm A passerby reported a young woman apparently in distress on Marble Avenue. Responding officers located the young woman and attempted to de-escalate her and assist her to regulate her emotions. Her family was contacted, and her father arrived on scene to assist. Since she was not determined to be a threat to herself, once she calmed down, she was released back to her father's custody.

10/16/2023 6:51pm A resident of Pleasant Avenue reported two vehicles parked partially in the roadway, with another car parked nearby with its hazard lights illuminated. The responding officer determined the first car was disabled, and the second was assisting.

10/16/2023 9:25pm County Fire Control reported they were dispatching EMS to a local residence for an elderly female with injuries from a fall. Officers responded and rendered basic assistance pending their arrival. The patient was transported to the hospital via Pleasantville VAC.

10/17/2023 10:17am A resident of Meadow Lane requested transport to the hospital, as she had not been feeling well for the past few days. The ambulance and paramedic were dispatched, and responding officers found the woman waiting for them outside her home. The officers kept her comfortable while awaiting EMS, and she was transported to the hospital via Pleasantville VAC.

10/18/2023 10:47am A resident of the Sherman Park area of Pleasantville reported a dog barking excessively. Responding officers found the area quiet, but were able to determine the source of the noise as a home on Meadow Lane. They spoke to the dog's owner, and advised her of the prohibition on excessive barking.

10/18/2023 6:18pm The driver involved reported striking a pedestrian with her car while he was crossing Bedford Road at the intersection with Romer Avenue. The driver was checking for traffic and did not notice the man in the crosswalk. EMS was dispatched, and responding officers assisted with traffic control as it was determined the pedestrian did not sustain an injury. A NY State Accident Report was filed.

10/19/2023 8:15am One of the drivers involved reported a property damage motor vehicle accident on Grant Street near the intersection with Pleasant Avenue. Officers determined that the accident occurred because of an illegal turn off the Saw Mill River Parkway. A NY State Accident Report was filed, and the driver was issued a summons for the illegal turn.

10/19/2023 3:19pm An anonymous caller reported a black SUV parked and obstructing traffic at the intersection of Grandview Avenue and Manville Road. Responding officers asked the driver, a resident of Pleasantville Road, to move his vehicle, but he became argumentative and accused the officers of targeting him instead of addressing other cars which he believed should be summonsed. He eventually left the area.

10/19/2023 7:51pm A resident of Bedford Terrace reported multiple cars parked in violation near his home. The responding officer issued multiple summonses.

10/19/2023 8:10pm A local resident requested a welfare check on a friend who lives on Bedford Road that he had not heard from in a couple of days. Upon arrival, responding officers interviewed the person in question and determined she was not a threat to herself. Mental health services were offered, but were declined.

10/19/2023 9:00pm The owner of a business on Irvington Street reported a suspicious person meandering up and down the street. A description was provided, and responding officers located the man in the area. He was identified as a local resident who stated he was out for a walk.

10/20/2023 9:33am A social services case worker requested EMS for her client, who was having difficulty breathing and suffering from an altered mental state. The paramedic and the ambulance were dispatched, and responding officers treated the man with oxygen pending their arrival. The patient was transported to the hospital by Pleasantville Ambulance.

10/20/2023 12:20pm A resident of Florida requested a welfare check on her adult daughter, who lives on Bedford Road. The mother reported that an earlier conversation had left her concerned for her daughter's wellbeing. Responding officers interviewed the daughter, who admitted to thoughts of self-harm in the recent past. EMS was requested to respond, and the patient was transported to the hospital for a mental health evaluation.

10/20/2023 10:29pm A resident on Broadway reported an alarm activation at her residence for unknown reasons. Responding officers were dispatched and, after arriving on scene, they determined the alarm was malfunctioning.

10/21/2023 8:02am The daughter of a Village resident who suffers from dementia reported she had detected that he had left his home unsupervised. Responding officers canvassed the area, and his location was eventually determined to be in the Town of New Castle. New Castle PD assisted in searching for the man, who was eventually located in good health and returned to his home.

10/21/2023 10:19am The parking assistant at the Pleasantville Farmer's Market reported a verbal dispute with a wrong-way driver in Memorial Plaza. Responding officers attempted to interview both parties involved in the dispute, but the driver, a resident of Brooklyn, refused to answer any questions about the incident. Since the dispute was only verbal, the man was sent on his way.

10/21/2023 12:27pm One of the vendors at the Pleasantville Farmer's Market reported a larceny of vegetables from her stand. A woman had approached her and stated that she had arranged with the farm's owner for some vegetables, citing food insecurity. However, the employee became concerned after the woman collected a vast quantity of vegetables and left the area. When contacted, the owner of the farm reported he had received an email from the woman requesting food, and he had consented, but they had not agreed on an amount. A canvass of the area for the woman was negative. The owner did not wish to press charges, but Market management requested that the woman not be allowed back on the Market grounds.

Her information and photograph were collected from the farmer and his employee, and the incident was documented with a police report.

10/22/2023 1:11am A resident of Bedford Road reported several loud groups of people walking westbound on Bedford Road. Officers canvassed from the downtown area to beyond the Village line, but the people had left the area.

10/22/2023 9:30am A resident of Manville Road reported that she was not feeling well and had lost consciousness, sustaining an injury. The ambulance and the paramedic were dispatched, and responding officers monitored her condition pending their arrival. The patient was transported to the hospital via Pleasantville VAC.

10/22/2023 10:34am The central monitoring station for an alarm company reported an alarm activation at a public facility on Bedford Road. Responding officers determined that the alarm was accidentally triggered by the cleaning company.

10/22/2023 4:45pm County Fire Control reported they were dispatching EMS to a home on Madison Avenue for a woman not feeling well. Responding officers assisted in preparing the patient for transport, and she was taken to the hospital by Pleasantville VAC.

10/22/2023 8:38pm An employee of a restaurant in Memorial Plaza reported a minor disturbance in which a young person who appeared to be running from an adult female came into the restaurant. Responded officers determined the adult was attempting to re-secure an AWOL student from a local residential treatment facility. Responding officers de-escalated the youth, who eventually returned to campus.
