

BLOTTER SUMMARY

October 23rd through October 29th, 2023

The Blotter reports below represent a selection of reports made between the dates above.

10/23/2023 3:35am A resident of Country Club Lane reported his adult son had locked him out of the house and was acting out. Responding officers de-escalated the young man and determined he had damaged some items inside the house. The young man's parents declined to press charges, and a NY State Domestic Incident Report was filed.

10/23/2023 12:35pm A resident of Rye came to Police HQ to report being struck by a vehicle while crossing Tompkins Avenue at the intersection with Bedford Road by a vehicle which then left the scene. A vehicle description was provided, and the vehicle and driver were located. Once interviewed, the driver stated he had seen the pedestrian in the crosswalk, but did not realize he had struck him. After a few moments together, the pedestrian decided he did not wish to pursue charges against the driver. The pedestrian refused medical attention, and a NY State Accident Report was filed.

10/23/2023 9:28pm The central monitoring station for an alarm company reported a commercial burglar alarm activation at a store on Pleasantville Road. Responding officers checked the ground floor of the building and found it secure.

10/24/2023 1:13am County Fire Control reported they were dispatching Pleasantville FD reports a commercial fire alarm at a business on Castleton Avenue. Officers checked the exterior of the building and found it secure. Pleasantville Fire made entry to the building and determined the alarm was caused by a faulty smoke detector.

The man reported as he was filling up, a truck backed into his vehicle. The responding officer facilitated the exchange of information, as both drivers were agreeable to handling the matter privately.

Responding officers determined that the property was left behind by a party who ran down the street barefoot. Following a canvass, the man, a resident of the Bronx, was located and complained of a foot injury. EMS was dispatched, and the man was transported to the hospital via Pleasantville VAC.

10/25/2023 7:24pm One of the drivers involved reported a motor vehicle accident without injuries on Manville Road at the intersection with Grant Street. Responding officers determined that one of the cars attempted to make a left turn from Manville onto Grant when they were struck by a vehicle being operated westbound. A NYS Accident Report was filed, and both vehicles were towed from the scene.

10/26/2023 5:35am Ring Alarm Monitoring reported a residential burglary alarm at a residence on Bedford Road. The responding officers determined that the alarm was set off in error by the homeowner.

Eventually, the woman dropped the youth off at the Ossining Train Station. Ossining PD was contacted and located the youth, who was then turned him over to school staff upon their arrival.

With assistance from Mt Pleasant PD personnel, the caller's location was determined to be on Manville Road. EMS was dispatched, and the man was transported to the hospital by a mutual aid ambulance.

10/27/2023 12:43pm A resident of Bedford Road reported wires down near the Old Village. The responding officer located the wires, which were still affixed to the pole but hanging low, and determined they were telephone wires. Verizon was notified.

Officers from Pleasantville and Mount Pleasant police departments responded and extensively canvassed. A tracking K9 was requested from County Police. A short time later, a Mount Pleasant officer was flagged down by a driver, who reported he had picked up the woman to help her search for her family. The mother was reunited with her daughter and returned home safely.

10/27/2023 5:34pm A resident of Washington Avenue reported a woman had fallen at a store on Pleasantville Road and needed medical assistance. EMS was dispatched, and responding officers administered basic first aid while awaiting their arrival. The patient was taken to the hospital by Pleasantville Ambulance.
