BLOTTER SUMMARY

5/30/2022 through 6/6/2022

The Blotter reports below represent a selection of reports made between the dates above.

05/30/2022 12:14am A young girl called 911 to report a loud verbal argument between her father and his girlfriend. Responding officers were met by the caller's father who stated that he was watching a soccer game, and a verbal argument ensued between the two adults over the amount of noise he was making watching the game. Officers determined that no crime had been committed, but completed a NYS Domestic Incident Report and the father agreed to spend the night elsewhere.
