

## **BLOTTER SUMMARY**

**November 20th through November 26th, 2023**

The Blotter reports below represent a selection of reports made between the dates above.

11/20/2023 6:58am Mount Pleasant PD requested Pleasantville units respond to a 911 hang up call on Mountain Road in their jurisdiction, due to a high call volume. Responding officers determined the caller did not have an emergency, only a medical question.

11/20/2023 7:52am County Fire Control reported they were dispatching the paramedic and the ambulance to a home on Garrigan Avenue for a woman who was having trouble moving. Responding officers assisted EMS to prepare the woman for transport. She was taken to the hospital via Pleasantville VAC.

11/20/2023 11:49am A resident of Washington Avenue reported his vehicle was unable to be moved after a wheel came off while he attempted to avoid an accident on Washington Avenue. Responding officers requested a tow truck, and the vehicle was towed for repairs upon their arrival.

11/20/2023 6:34pm A resident of Saratoga Avenue reported the vehicle of a person who was recently evicted is parked in front of the residence. Responding officers found the vehicle unoccupied, and canvassed the area, but the former resident was not located.

11/20/2023 8:31pm A person living abroad requested a welfare check on a friend who lives on Bedford Road. After a brief investigation, responding officers located the woman at a home outside of the Pleasantville jurisdiction, and determined that she was in need of medical attention. The medic and the ambulance, along with the Mobile Crisis Response Team, were dispatched, and the patient was transported to the hospital via Pleasantville VAC.

11/20/2023 8:31pm Two separate members of a family called to request a welfare check on a man who lives in the Village who was not answering his phone. Officers responded and spoke to the family member in question, who reported his phone was off.

11/21/2023 3:32am A resident of the Village requested a police presence at his home while he dealt with his adult son, who lives elsewhere but had come to the home for money. Responding officers remained on the scene until the father took the son back to his own residence.

11/21/2023 9:37am A resident of Pleasant Avenue reported a sign had been knocked down in the area of the intersection of Grant Street and Depew Street. DPW was notified to return the sign to its proper location.

11/21/2023 10:38pm A young man came to Police HQ and requested assistance finding shelter. The Mobile Crisis Response Team was contacted, and responding officers assisted with getting the man placement in, and transport to, a shelter in Peekskill.

11/22/2023 1:43am A resident of Pleasant Avenue reported a tree down with arcing wires on Pleasant Avenue near the intersection with Congress Street. Responding officers closed the roadway and requested Con Edison to respond. DPW was notified for tree removal.

11/22/2023 9:06am A resident of Bismark Street requested assistance for a carbon monoxide alarm activating in her home. Pleasantville Fire was dispatched via County Fire Control, and responding officers remained on scene to assist until the home could be deemed safe.

EMS was dispatched, and responding officers attempted to keep the party comfortable and safe pending their arrival. Following a medical evaluation, the young man refused further medical attention.

11/22/2023 8:16pm A passerby reported two youths riding their bicycles in the middle of Manville Road in the area of Roselle Avenue. Responding officers located the boys in Roselle Park. They agreed to keep their bicycle riding to safer areas.

11/23/2023 2:08am Staff members of a local nighttime establishment on Bedford Road requested assistance in removing an unwanted patron. Responding officers were able to escort the man, who would not provide his pedigree information, from the bar without further incident.

Following a brief search of the area, the vehicle was located on Marble Avenue. Responding officers found that the man would not respond to them, and determined he was under the influence of a substance. The ambulance and the paramedic were dispatched, and the man was transported to the hospital by Pleasantville VAC.

11/24/2023 1:32pm A resident of Washington Avenue reported a broken window under unknown circumstances. Responding officers conducted a primary investigation, and although the situation did not appear to be an attempted burglary, the investigation is ongoing.

11/24/2023 3:40pm While off duty, a police officer located a distraught young woman sitting on the sidewalk on Bedford Road. The young woman was brought inside the Police HQ lobby and officers assisted her to regulate her emotions. Service were offered but were declined. She left once she felt well enough to walk home.

Officers rendered basic assistance while awaiting the arrival of the ambulance and paramedic. Upon their arrival, the woman refused further medical assistance.
