

## **BLOTTER SUMMARY**

**December 18rd through December 24th, 2023**

The Blotter reports below represent a selection of reports made between the dates above.

12/18/2023 4:30 am Multiple reports of trees and wires down, impassable roads and power outages were received. Officers contacted various resources, including Con Edison and DPW personnel, to mitigate the damage and maintain safety.

12/18/2023 9:26am County Fire Control reported an activated alarm on Robbins Road with elevated gas readings. Responding officers assisted the fire department in evacuating the residence. Con Edison was notified and responded to the residence to address the condition.

12/18/2023 9:46am A resident of Washington Avenue reported two vehicles damaged in the overnight storm. A report was taken for the damaged property.

12/28/2023 12:46pm An anonymous caller walking by a business on Wheeler Avenue reported a person who she believed to be deceased inside. Responding officers determined the man was merely sleeping, and provided him with a meal while they waited the arrival of the Mobile Crisis Response Team. The man was ultimately connected to a shelter in New York City and departed on the southbound train.

12/28/2023 4:32pm A resident of Yorktown reported her father, an Alzheimer's patient who lives in the Village, had left home. Utilizing technology, the man's daughter determined his location to be on Bedford Road going into Chappaqua. Responding officers located the missing man and returned him to his residence.

12/18/2023 5:26pm A resident of Parkway Terrace reported a tractor trailer had gotten stuck attempting to turn from Manville Road. The responding officer assisted the driver to maneuver the truck out of the roadway safely.

12/18/2023 8:56pm A resident of Grove Street reported a vehicle blocking his driveway. The responding officer issued a summons.

12/18/2023 10:06pm A caller reported a tractor trailer parked on Depew Street at the intersection of Vanderbilt Avenue in violation. The responding officer located the trailer and a summons was issued.

12/19/2023 7:50am A resident on Manville Road called to report their vehicle had been entered without permission by an unknown person who ransacked the contents and then left the driver's side door ajar. The responding officer took a report, and the investigation is ongoing.

12/19/2023 8:32am The central monitoring station for an alarm company reported a residential carbon monoxide alarm on Washington Avenue. Pleasantville Fire was dispatched, and responding officers assisted to ascertain that the alarm was a malfunction.

12/19/2023 10:48pm A resident of Pierce Drive reported a white vehicle with a loud muffler had driven down their driveway, then backed out at a high rate of speed. Responding officers checked the surrounding areas, but the vehicle was gone upon arrival.

12/20/2023 12:48am County Fire Control reported they were dispatching EMS for an intoxicated party at the Pleasantville Train Station. Responding officers found that the party was on the train platform, and MTA Police were already on scene. The party was eventually transported to the hospital.

12/20/2023 9:09am A Brewster resident reported a man with injuries from a fall on the ice on Greenmeadow Road. EMS was dispatched, and responding officers attempted to

keep him comfortable pending their arrival. The patient was transported to the hospital via Pleasantville Ambulance.

12/20/2023 11:00am Members of the Patrol and Detective Divisions participated in a County-wide mutual aid drill at Pace University.

12/20/2023 12:09pm A resident of Peekskill came to Police HQ to report that she had lost her iPhone 14 the day prior, near the intersection of Manville Road and Pleasantville Road. A lost property report was filed.

12/20/2023 5:42pm A treating physician reported that one of her patients was acting irrationally and making threats to other people from his home in the Village. Responding officers spoke to both the man and his mother, and he was eventually transported to the hospital via Pleasantville VAC.

12/20/2023 10:47pm A neighbor reported loud music coming from a backyard on Great Oak Lane. Responding officers advised the homeowner of the village noise ordinance, and the music was turned off for the night.

12/21/2023 12:20pm A resident of Robbins Road reported a family member who had suffered injuries from a fall. EMS was dispatched, and officers provided basic first aid pending their arrival. The patient was transported to the hospital via Pleasantville VAC.

12/21/2023 12:25pm A local resident came to Police HQ to report unwanted text messages which she believed might be from an ex-boyfriend. The incident was documented with a police report.

12/21/2023 2:02pm The Mount Pleasant Police Department requested mutual aid at a residential treatment facility for a suspended student who had returned without permission and was combative. Responding officers assisted to keep the scene safe until the student in question was located and removed.

12/21/2023 6:12pm One of the drivers involved reported a motor vehicle accident at the intersection of Manville Road and Pleasantville Road. The responding officer managed the traffic concerns and requested EMS for a medical evaluation due to an airbag deployment. Following the evaluation, the driver refused further medical attention. A tow truck was requested, and one vehicle was towed from the scene. A NY State Accident Report was filed.

12/22/2023 1:10 am A resident of Manville Road reported multiple cars parked with their lights on in the area of the intersection with Great Oak Lane. Responding officers located the owners and corrected the situation.

12/22/2023 11:43am Officers responded to the area of Grove Street near Edgewood Avenue on the report of an abandoned vehicle parked in the same spot for an extended period of time. The responding officers made contact with the registered owner, who stated he could not remove the vehicle in the near future because it was disabled. A tow truck was requested, and the vehicle was impounded.

EMS was dispatched, and responding officers found the man to be conscious and responsive. Following a brief examination by the paramedic and ambulance crew, the man refused further medical attention.

12/23/2023 9:15am A resident of Sunnyside Avenue came to Police HQ to turn over a purse he had found near his home which contained a sizeable amount of cash and checks. The desk officer performed a brief investigation, which led to the discovery of the purse's owner. She was contacted and responded to Police HQ to retrieve her property.

12/23/2023 10:28am The central monitoring station for an alarm company reported a commercial fire alarm at a business on Castleton Street. The responding officer assisted Pleasantville FD personnel to determine that all was in order.

12/23/2023 12:33pm A supervisor from the Post Office reported that one of the mail carriers had been bitten by a dog while performing his rounds on Edgewood Avenue. The responding officer interviewed the victim and identified the dog, who was current on his vaccinations. The wound was treated, and the victim refused medical attention. The completed dog bite report was forwarded to the Westchester County Board of Health.

12/23/2023 1:08pm County Fire Control reported they were dispatching EMS to a unit in the Foxwoods Condominiums for a woman with difficulty breathing. Responding officers provided oxygen while awaiting the arrival of the paramedic and the ambulance. The patient was transported to the hospital via Pleasantville VAC.

12/23/2023 1:58pm A resident of Bedford Road reported a female yelling in the street. Responding officers located the woman at the intersection of Bedford Road and Wheeler Avenue, and found out she was upset that the Bee-Line bus was not on schedule. Officers attempted to calm her down until the bus eventually arrived.

12/23/2023 4:51pm A owner of a business on Marble Avenue reported a loud humming noise coming from the business next door, which is closed. The responding officer confirmed the noise, and once the business owner was contacted and entry was made, it was determined an amplifier had been left on.

12/23/2023 5:45pm A resident of Sunnyside Avenue came to Police HQ to report being struck in the arm by a vehicle while crossing the street at Bedford Road and Memorial Plaza about 30 minutes prior. The complainant reported that the driver of the vehicle stopped, and after a brief conversation, both parties agreed to go on their way. A description was provided, and after a brief investigation, the driver of the vehicle was located so a NY State Accident Report was filed.

12/24/2023 5:40am Several illegally parked vehicles were located in the area of Vanderbilt Avenue, Depew Street, and Grant Street. The responding officer issued eight (8) summonses.

However, while on scene, a second woman passed out, and a second ambulance was requested. Eventually, one of the two women was transported to the hospital via Pleasantville VAC, and the second patient refused medical attention.

12/24/2023 11:59 pm A resident of Weskora Avenue reported a car alarm repeatedly going off. Responding officers located the car and contacted the owner to correct the situation.
