## December 25rd through December 31th, 2023

The Blotter reports below represent a selection of reports made between the dates above.

12/25/2023 12:32am A resident of Manville Road called 911 to report some kind of disturbance, despite a language barrier. The responding officers determined that the caller was upset because a guest at her home spilled chili on the floor and refused to clean it up. Officers were able to deescalate the situation, and the party responsible eventually agreed to assist with the clean-up.
