06/20/2022 THRU 06/26/2022

The Blotter reports below represent a selection of reports made between the dates above.

06/20/2022 7:00am A female party from Dobbs Ferry reported that she had struck a male pedestrian with her vehicle in the crosswalk at Bedford Road and Cooley Street. The pedestrian was treated by Officers until EMS arrival, and then transported to the hospital by Pleasantville VAC. A NYS accident report was completed, and the vehicle operator was issued a summons for failure to yield the right of way to a pedestrian.
