

BLOTTER SUMMARY

6/27/2022 through 7/3/2022

The Blotter reports below represent a selection of reports made between the dates above.

06/27/2022 12:38 am Following a traffic stop for an equipment violation on Bedford Road, it was discovered that the driver, a Pleasantville resident, was driving with a suspended license. The driver was arrested and processed at the scene. She was charged with Aggravated Unlicensed Operation in the 3rd Degree and given a Desk Appearance ticket, returnable on her first court date.

06/27/2022 12:57pm A motorist reported a road rage incident with another driver. The caller stated that the other driver had thrown an unknown object at his car, causing damage to his vehicle. Responding Officers interviewed both drivers and secured video evidence which showed that the report was unfounded. Both drivers were released from the scene without incident.

06/27/2022 10:47pm A woman who wished to remain anonymous turned in a key fob for a Volvo she had found in the area of Manville Road and Brookfield Place. Officers canvassed the area in an effort to locate vehicle, but were unsuccessful. The fob was vouchered and placed into found property for safekeeping.

06/28/2022 9:37pm The manager from a restaurant on Marble Avenue reported concern for a possibly intoxicated male sitting at the bus stop across from the establishment. Responding officers searched the area around the restaurant but were unable to locate the man.

06/29/2022 10:38am A resident of Saratoga Avenue reported a suspicious van parked in front of her house. Officers checked the van and found no reason for concern, but did discover it had an expired registration. A summons was issued.

06/29/2022 5:40pm A resident of the Village came to Police HQ to report he was being extorted. He reported that he had been contacted via social media by a woman he did not

know. After multiple requests for explicit photos, he eventually complied. When he did so, the woman immediately threatened to release the photos to his family and friends unless a payment was made. The case is currently under investigation.

06/29/2022 9:15pm County Fire Control called to report an 81-year-old man had fallen down the stairs and sustained injuries at a residence on Ashland Avenue. Upon arrival, the man complained of neck pain and seemed to have difficulty remembering details of his fall to responding officers. Officers stabilized him until EMS arrived. He was transported to the hospital via Pleasantville VAC.

06/30/2022 2:15pm The central station monitoring system for an alarm company reported a carbon monoxide alarm activation at a home on Romer Avenue. Responding officers assisted Pleasantville Fire Department with traffic control and in assessing that the scene was safe.

06/30/2022 3:06pm Officers responded to a report of an electrical fire near the intersection of Bedford Road and Memorial Plaza. Responding officers reported active burning from primary electrical wires. Pleasantville Fire Department and Con Edison responded to the scene and the situation was corrected.

06/30/2022 5:32pm One of the drivers involved reported a minor property damage auto accident on Bedford Road at the intersection with View Street. Officers assisted the drivers with exchanging their information, and issued a summons to one of the drivers involved for having an expired registration.

06/30/2022 6:34pm A resident whose property is near the Village line with the town of Mount Pleasant called to report a man down in his neighbor's driveway. Officers from both Pleasantville and Mount Pleasant PD's responded. It was determined that the case was in the jurisdiction of Mount Pleasant.

06/30/2022 7:32pm A resident of Washington Avenue called to report that the electrical wires to his neighbor's house were on fire. Pleasantville FD and Con Edison responded. Fire department personnel confirmed no damage to the structure, as the fire did not reach the house.

07/01/2022 1:16am A resident of Mountain Road reported that a Fed Ex truck had struck a street sign at the intersection of Mountain Road and Crawford Street. The responding officer found that the truck had left the scene, but he was able to re-secure the sign.

07/01/2022 5:49am A resident called reporting a tree down across Sunnyside Avenue near Marble Avenue. The Officer who responded confirmed that the roadway was partially obstructed and requested assistance to clear it. Public Works personnel were notified to clear the road.

07/01/2022 1:20pm The manager of a work crew reported that a vehicle belonging to one of his workers had been stolen from in front of the jobsite on Lake Street. After gathering a description of the vehicle, officers checked the area and located the vehicle unoccupied in the parking lot of a business on Pleasantville Road. After members of the Detective Division processed the vehicle for evidence, it was returned to the owner. The investigation is continuing.

07/01/2022 1:42pm A resident of Manville Road called 911 to report she needed transport to the hospital due to a high fever and a concern she was COVID-positive. An ambulance and paramedic were requested, and the officers assisted in getting her the attention she required. She was transported to the hospital via Pleasantville VAC. She called back later to advise that her COVID test was negative.

07/01/2022 6:57pm The central station system for an alarm company reported a burglar alarm at a commercial establishment on Wheeler Avenue. Responding Officers checked all entry/exit points, and reported the location secure.

07/02/2022 3:51am County Fire Control reported a 22-year-old male with difficulty breathing at a residence on Manville Road. Responding Officers located the party outside of his residence, and provided him oxygen until while awaiting the arrival of EMS. He was transported to the hospital by Pleasantville VAC for further treatment.

07/02/2022 4:24pm A Chappaqua resident called reporting that he had been involved in an automobile accident on Manville Road near Tompkins Avenue. The responding Officer reported there were no injuries, and that one of the drivers had left the scene prior to his

arrival. A New York State Accident Form was completed and a driver who did not facilitate the exchange of information was issued a traffic summons for leaving the scene of an accident.

07/03/2022 12:45am A resident on Tompkins Avenue reported that her husband was having abdominal pains and needed medical assistance. Responding Officers assisted the man, who was evaluated by EMS personnel. After the evaluation, the man refused additional medical attention, and chose not to go to the hospital.

07/03/2022 11:53am A resident of the Clinton Street Center reported a power outage in the building. Responding officers determined that the generator was malfunctioning, and that there was a person in the elevator. Pleasantville Fire, Con Edison and the management company for the building were notified and responded. From one of the affected residents:

"They checked on each senior, checked that no one was trapped in the elevators, checked that no one was on oxygen etc. They kept us calm, even thought to have us open our doors for cross ventilation. Their presence did much to assuage our fears in the stifling heat."

07/03/2022 3:20pm A family member called to report that her elderly relative had fallen, and was too weak to stand up on his own, at a residence in the Foxwood Condominiums. Responding Officers found the man to be dehydrated. An ambulance and a paramedic were dispatched. The party was transported to the hospital by Pleasantville VAC.

07/03/2022 5:51pm A resident of Meadow Lane reported that his father was suffering ill effects from the heat. The ambulance, and a paramedic were dispatched along with our officers. After being treated for a short time, the man refused further medical attention.

07/03/2022 8:06pm A Life Alert service reported a resident of the Clinton Street Center was in need of a lift assist. Responding Officers discovered the resident on the floor of her bedroom with an injury to her mouth. An ambulance and a paramedic were requested to respond. Officers assisted her up and provided first aid until EMS arrival. The resident declined further medical attention.
