## **BLOTTER SUMMARY**

## 7/4/2022 through 7/10/2022

The Blotter reports below represent a selection of reports made between the dates above.

07/04/2022 7:10am A resident of Center Street reported that his elderly mother had fallen and hit her head. After a brief evaluation by responding officers, an ambulance and paramedic were requested to respond. The patient was transported to the hospital via Pleasantville VAC.

07/04/2022 1:31pm A resident of Douglas Drive reported that he had come to his father's home and found him unresponsive. Upon arrival, responding officers confirmed the man was deceased. An investigation of the scene and the victim provided no signs of criminality. The paramedic on scene pronounced the victim, and officers assisted with the family and the victim's physician to expedite his removal to the funeral home.
