7/11/2022 through 7/17/2022

The Blotter reports below represent a selection of reports made between the dates above.

07/11/2022 7:17am The theft of power tools from a construction site on Vanderbilt Avenue was reported by a worker there. The theft is believed to have occurred sometime between Saturday at 3:30pm and Monday at 7:00am. Responding officers canvassed the area and completed the initial investigation, and Detectives are continuing the investigation.
