## **BLOTTER SUMMARY**

## 7/18/2022 through 7/24/2022

The Blotter reports below represent a selection of reports made between the dates above.

07/18/2022 9:25am The manager of a bank on Washington Avenue reported a disruptive customer in the branch. The customer had left the scene prior to their arrival, but the issue is ongoing, so officers advised bank employees to call back should another issue arise.

07/18/2022 1:28pm A resident of Douglas Drive reported a young man walking through her yard who appeared confused or disoriented. The caller provided a description and a direction of travel, but officers did not locate him.

Chiarlitti determined that the vehicle's registration was suspended for failure to maintain insurance.
